Consequently, any demand for payment under this guarantee must be received by us at the office on or before that date.

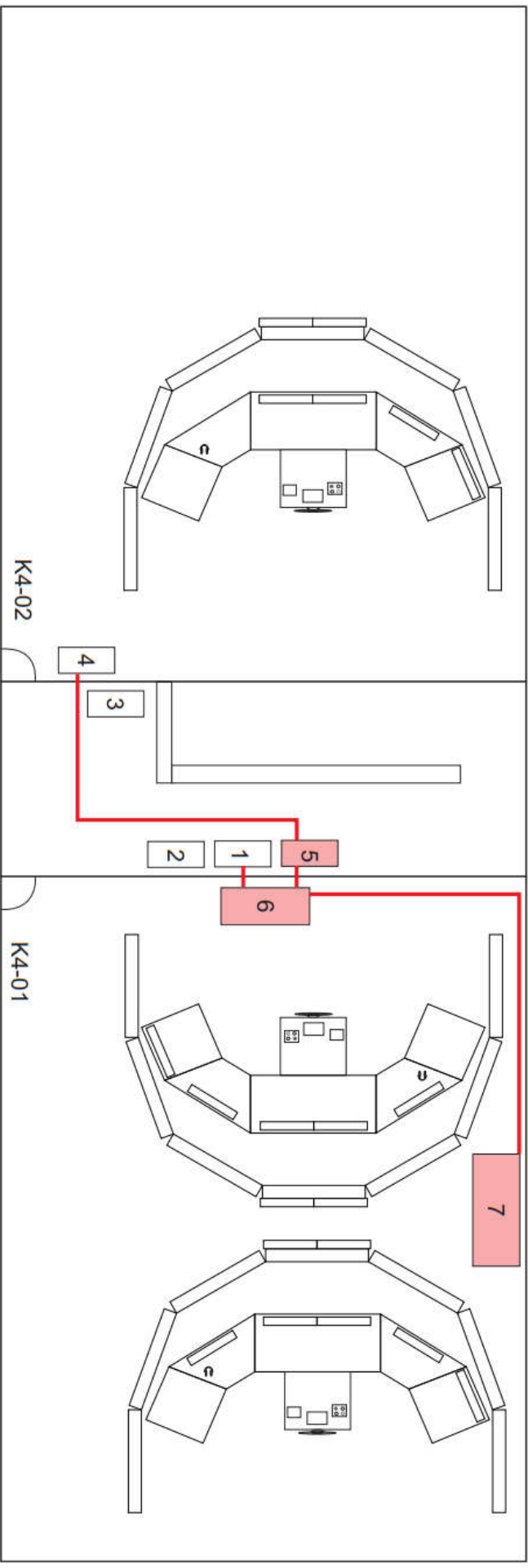
