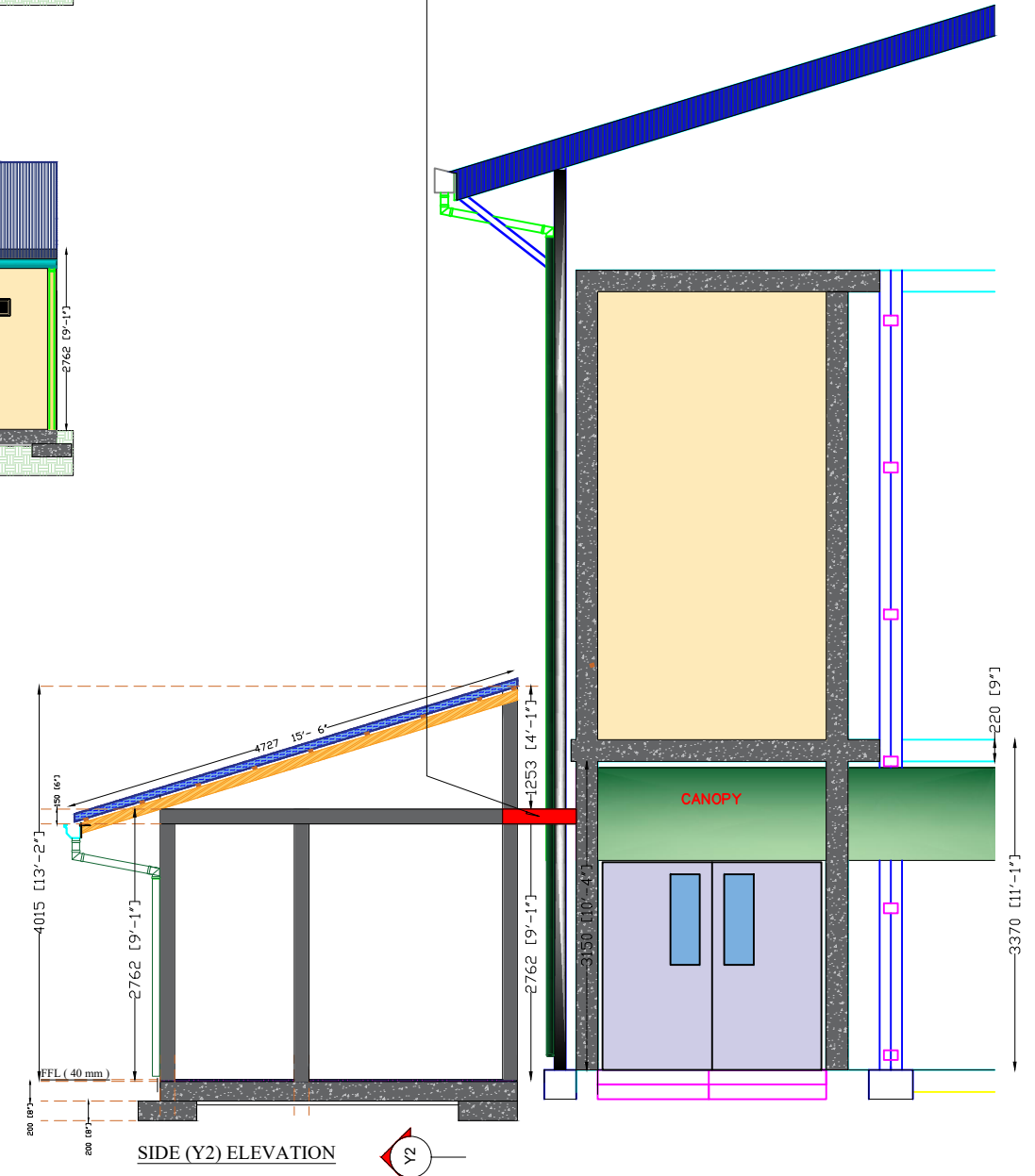

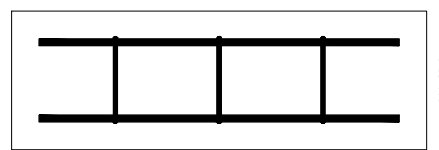
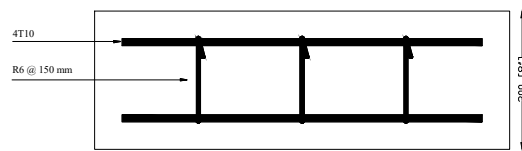


Sectional view column and footing

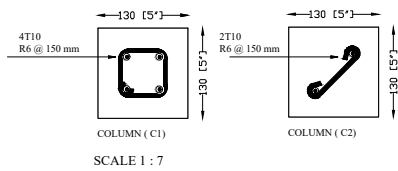
FOOTING (F2)

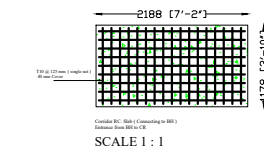
