BOUNDARY WALL DETAIL

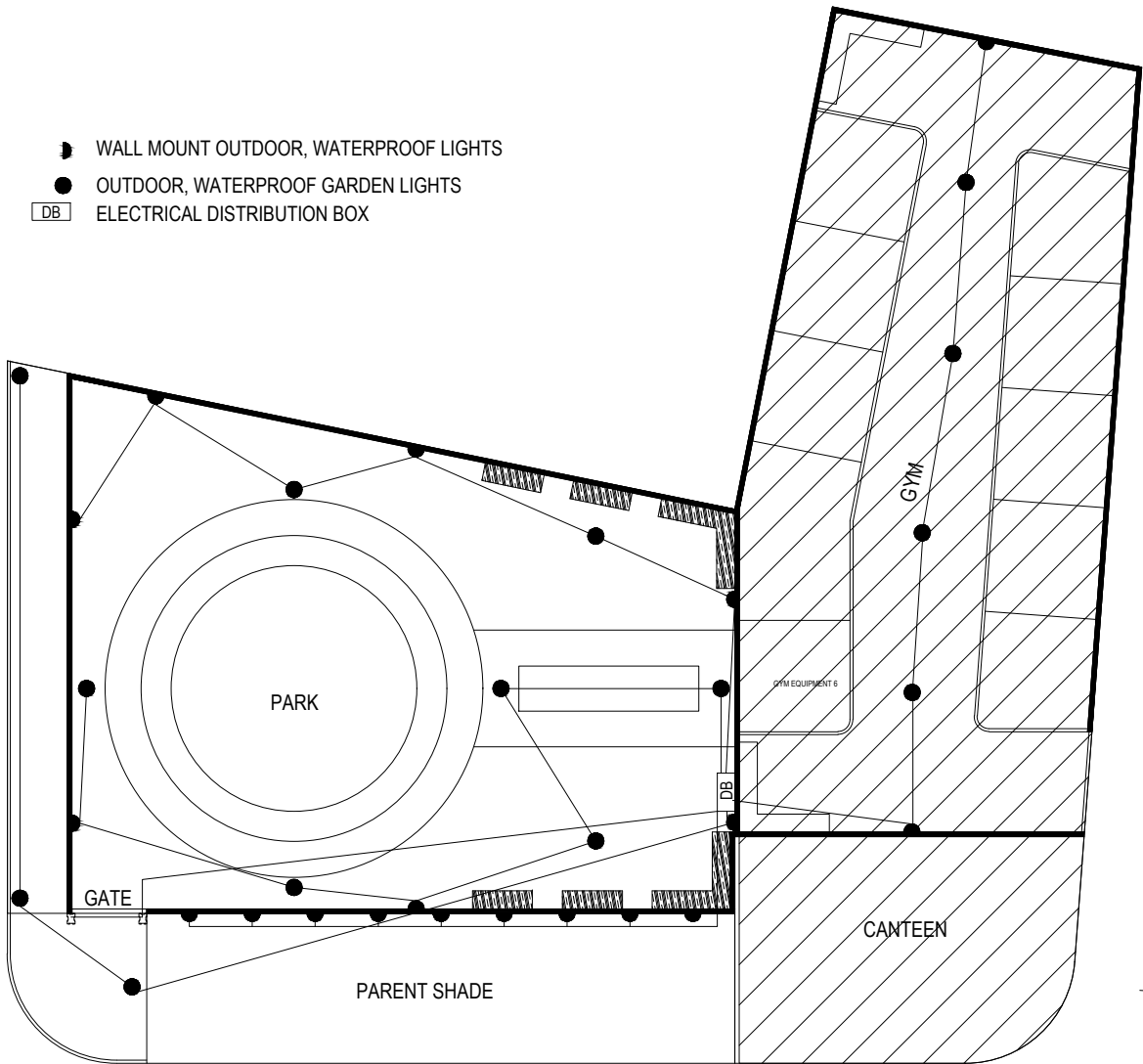

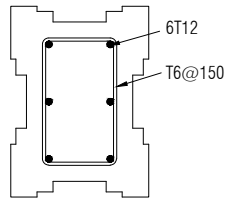

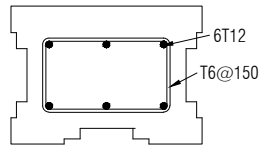


ELECTRC LAYOUT

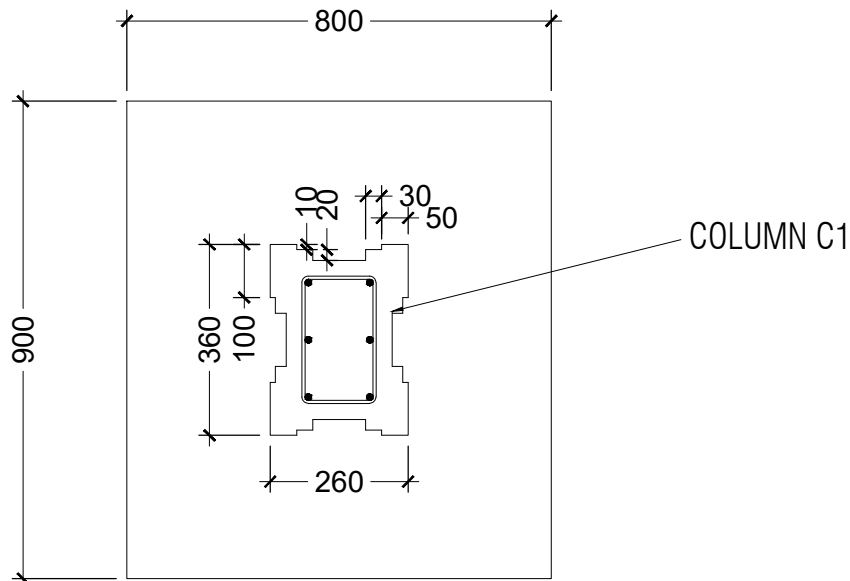




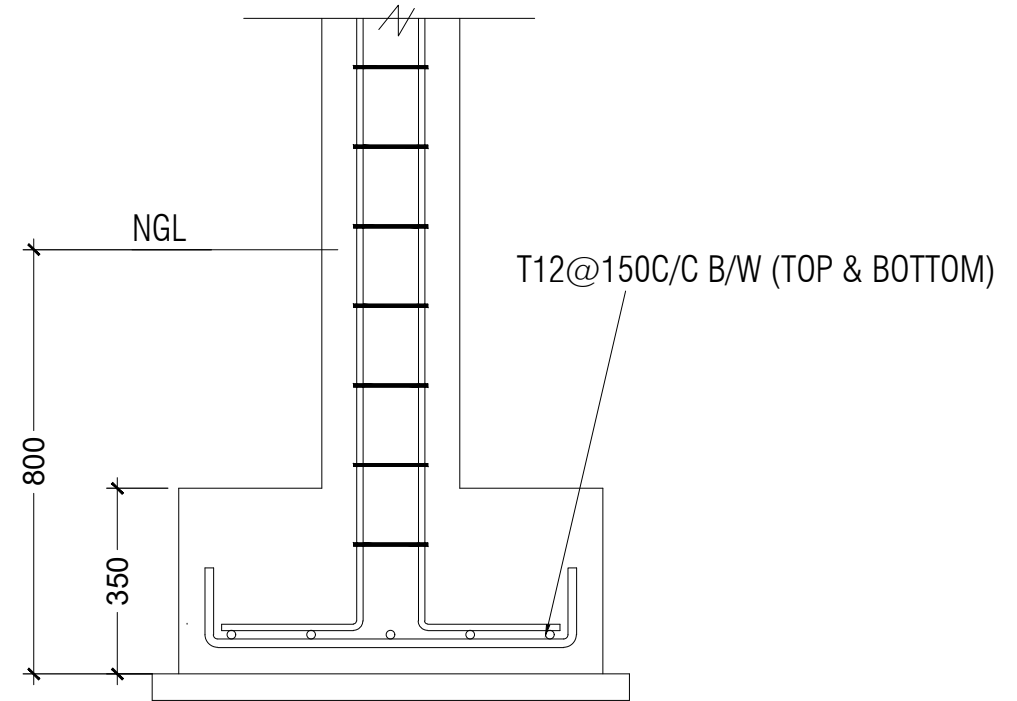

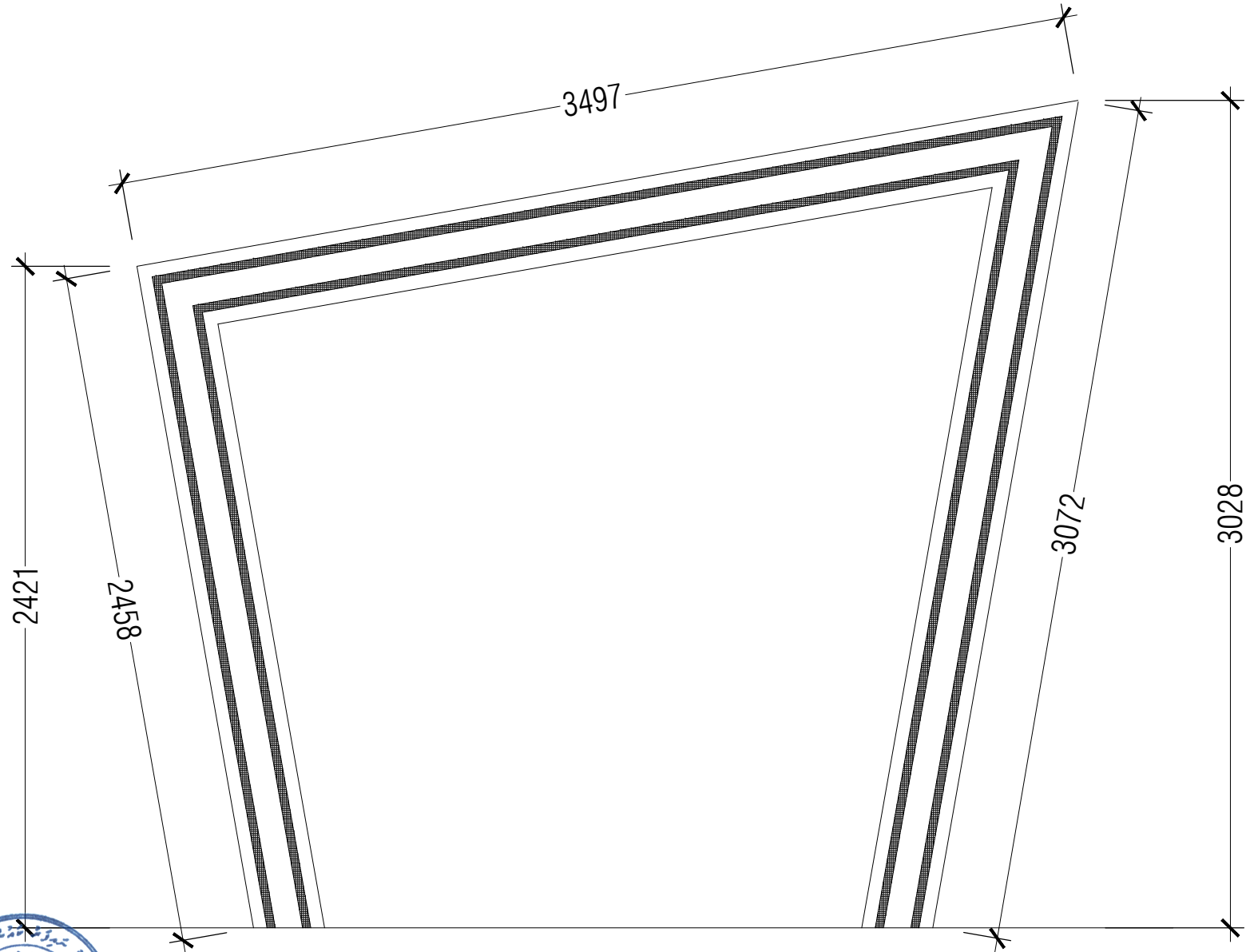
