STAGE 1 – DOCUMENT CHECK AND ELIGIBILITY

• Check and verify the documents submitted by the Applicants.

STAGE 2 – EVALUATION

• To evaluate EOI documents that fulfill the requirements in Stage 1.

STAGE 3 – NEGOTIATIONS

• Further negotiate terms and conditions with eligible or highest scoring applicant.

STAGE 4 – APPROVAL

• The final proposal will be shared to Filladhoo Council's endorsement.

STAGE 5 – CONDITIONAL AWARD

• Once the Proponent is endorsed by Filladhoo Council, the commercial space will be conditionally awarded.

STAGE 6 – CONTRACT SIGNING

- Upon notification of the conditional award, Filladhoo Council shall send the draft Agreement.
- Proponent shall sign the Agreement with Filladhoo Council within 7 days.
- Failure of the successful Proponent to fulfill the obligations in conditional award letter or sign the Agreement shall constitute sufficient grounds for the annulment of the conditional award.
