Delivery: 10 points for the lowest delivery period

- (Lowest delivery period / proposed delivery period) x 10
- If the delivery period indicates 'ex-stock', it shall be taken same as the party offering the longest delivery period.

Credit Period: 10 points for the maximum credit period.

(Proposed credit period / longest credit period) x 10

Experience: 20 Points
