# 2. Each LOT will be evaluated and awarded Separately.

#### **Price:**

- 3.1.1 Each bidder's price is used to identify their relative position on a 0-70 price scale. This is done by allocating the lowest priced bid 70 points and calculating the remaining bidder's score in relation to this scale.
- 3.1.2 Price percentage = 70 x (lowest price / bid price)

## **Delivery:**

- 3.1.3 Each bidder's Delivery is used to identify their relative position on a 0-15 price scale. This is done by allocating the lowest Delivery bid 15 points and calculating the remaining bidder's score in relation to this scale.
- 3.1.4 Delivery percentage = 15 x (Lowest Delivery / Bid Delivery)
- 3.1.5 The maximum delivery period shall be 60 calendar days from the date of confirmation.

#### **Experience**

3.1.6 A total of 15 points is allocated for Proof of supply of similar Equipment's to other organizations within last 5 years. (Letter from user/organization mentioning successful delivery of similar equipment's.) for each successful implementation 5 points will be awarded with a maximum of 15 points.

## How bid document will be deemed invalid or disqualified

- 4.1 Department of National Registration shall confirm that the following documents and information have been provided in the Bid. If any of these documents or information is missing, the offer shall be rejected or deemed Invalid at evaluation stage.
