# TERMS OF REFERENCE

### 1. Introduction:

Maldives Integrated Tourism Development Corporation (MITDC) is looking for a party to rent a space for office as per the requirements of MITDC.

Contract period minimum 05 years.

# 2. Requirements:

- 2.1. Area / Floor size in square feet should be greater than 1800 and less than 3000
- 2.2. 2 floors adjustment is acceptable
- 2.3. Easy Access to the building
- 2.4. Minimum 02 toilets / Pantry
- 2.5. The office space should be cleaned and painted before it is handed over to MITDC
- 2.6. All parties should submit relevant and valid documents to support the above criteria.

- 3.1.1.1. Copy of Company Registration Certificate
- 3.1.1.2. Building Registration

- 3.1.1.5. If the bidder is subletting the building or floor, letter of permission from the landlord for the contract period.
- 3.1.1.6. Details of the available facilities
- 3.1.1.7. Recent Picture
- 3.1.1.6. If under construction, work completion schedule.

### 3.2. Advance and Rent

Submit the proposal along with the advance and rent payment amount and terms for renting the space.

Marks will not be awarded for respective categories for the bids that are received with incomplete information.

## 4. Evaluation criteria:

## 4.1. Budget (40 MARKS):

- 4.1.1. Monthly Rent Lowest rent gets the highest marks (30 marks)
- 4.1.2. Advance Payment Lowest or No advance gets the highest marks (10 marks)

### 4.2. Location (14 MARKS):

4.2.1. Maximum marks will be awarded for prime locations

#### 4.3. Size of space (20 MARKS):

4.3.1. Marks will be awarded on pro rata basis on the floor space area

### 4.4. Facilities (26 MARKS)

- 4.4.1. Minimum two separate toilets (8 marks)
- 4.4.2. Availability of Lift/Service Lift (6 marks)
- 4.4.3. Security System such as CCTV, etc. (6 marks)
- 4.4.3. Other offices in the same building (6 marks)
