The specialist will be responsible for researching investment opportunities and developing investment proposals. This role requires a strong understanding of financial markets, excellent writing skills, and the ability to effectively communicate SDFC's requirements.

Key tasks, responsibilities:

- Prepare materials such as policy briefs, investment proposals, pitch decks and any other relevant documentation required to convey business objectives and strategies.
- Research and identify investment opportunities that align with SDFC's business objectives while conducting a cross-country analysis of similar models and projects undertaken.
- Liaise with the government, line ministries, vendors and other agencies to achieve business objectives.
- Execute the necessary negotiation process related to the terms and conditions of investment agreements to ensure alignment with SDFC objectives.
- Maintain a continuous line of communication to provide timely updates to investors regarding project progress, next course of action and financial performance of available opportunities.
- Collaborate with internal teams to ensure alignment between investment objectives, business requirements and project execution.
- Conduct thorough due diligence on potential investment opportunities, assessing financial
 performance, market dynamics, and regulatory considerations to mitigate risk and
 maximize returns.
- Proactive research on industry trends, market conditions, and regulatory changes that may impact investment decisions.
- Manage documentation and compliance requirements related to investment transactions, regulatory requirements and internal policies governing investment activities.
- Develop financial models and projections to assess the potential financial impact of investment opportunities and support decision-making processes and analyze investment performance and provide recommendations for strategic adjustments as needed.
- Provide support on ad hoc requests as required by the management.
