1. INTRODUCTION

Maldive Gas Private Limited (MGPL) invites interested parties to provide proposals to Space Leasing for MGPL Shop Utilization, as per the terms and conditions provided in this Document.

2. BACKGROUND

Maldive Gas Private Limited (MGPL), a subsidiary of State Trading Organization plc (STO), is engaged in the natural gas distribution market since 1999, catering to a customer base of over 40,000. Over the years we have emerged as the market leader in providing Liquefied Petroleum Gas (cooking gas) throughout the Maldives. In addition to LPG, we also provide a wide range of related appliances and industrial gases such as Acetylene, Argon, Nitrogen, and Helium. We are also the sole producer and supplier of medical oxygen catering to more than 95% of hospitals throughout the country.

3. **DEFINITIONS**

For the purpose of this Request for Proposal (RFP), the following words and expressions shall have the meaning hereby assigned to them except where the context otherwise requires: -

- 3.1 'MGPL' means Maldive Gas Private Limited, which expression shall unless excluded by or repugnant to the context include MGPL's representative.
- 3.2 'MGPL's Representative' means the staff or any person authorized by who would be in charge of work and would sign the documents on behalf of the MGPL.
- 3.3 'STO' means the State Trading Organization Plc, which expression shall unless excluded by or repugnant to the context include STO's representative.
- 3.4 'Consultant' means any person / firm / company or organization engaged in rendering professional services and shall include all his associates.
- 3.5 'Bid Submission Date' means 22nd July 2024, 10:00 hrs, or date extended according to the process stated herein.
- 3.6 'Bid Stage' means the period between the date of this RFP and Bid Due Date.
- 3.7 'LOA' means Letter of Award notification.

- 3.8 'Member or Associate' means shareholder/s of the Bidder or a partner in business.
- 3.9 'Subsequent Agreements' means one or more agreements, deed, instruments executed between MGPL and Selected Bidder pursuant to the Project.
- 3.10 'Laws' means, existing Laws and Regulations of the Republic of Maldives and any other applicable international protocol.

5. SCOPE

SPACE LEASING FOR MGPL SHOP UTILIZATION

OBJECTIVE

To find a competitive bidder capable of leasing a suitable space to operate a newly opened MGPL shop in Male', city.

IDEAL LOCATION

- Floor Area: 1200-2200 Sqft
- Preferred Areas: Ameenee Magu, Majeedhee Magu, Soasun Magu, Boduthakurufaanu Magu, and other prime locations in Male' city.
- Accessibility: Avoid narrow roads and lanes; high accessibility and visibility preferred.

UTILITIES AND AMENITIES

- Electricity: Availability of three-phase electricity supply with completed internal wiring preferred.
- Water Supply: Access to water supply is advantageous.
- Toilet(s): Presence of toilet(s) within the shop space is preferable.

LEASE TERMS AND CONDITIONS

- Expected Lease Duration: Preferably 10 years with options for renewal.
- Rent Payment Schedule: Monthly payments due on the 10th day of each month.
- Security Deposit/Advance Payment: Only one of these is required, not both. The amount should not exceed one month's rent.
- Access: Lessee must provide unconditional access to MGPL to conduct its business activities in compliance with Maldives laws/regulations.

REGULATORY COMPLIANCE

- Zoning and Building Regulations: Ensure compliance with local zoning laws and building codes.
- Permits and Licenses: MGPL will obtain necessary permits and licenses for the operation.

ADDITIONAL CONSIDERATIONS

Accessibility:

- Ensure the location is easily accessible to both customers and delivery vehicles.
- Verify proximity to major roads or transportation hubs for convenient access.

Visibility:

- Prefer a location with broad visibility to attract customers.
- Choose areas with low traffic congestion to facilitate easy access for customers.

Flexibility:

- Seek flexible lease terms to accommodate potential changes in business needs or expansion plans.
- Consider options for adjusting the lease terms (e.g., space expansion) as the business grows.

6. ADDENDA TO THE BID DOCUMENT

Before the deadline for submission of bids, MGPL may modify the Bid Documents by issuing addenda. The addenda shall be communicated in writing to all Bidders and shall become a part of the Bid Documents.

7. CLARIFICATION OF BID DOCUMENTS

A prospective bidder requiring any clarification of the Bid Documents may notify MGPL in writing to the mailing address <u>procurement@maldivegas.com</u>. MGPL will respond in writing to any request for clarification sent to **procurement@maldivegas.com ONLY**

8. INSTRUCTIONS TO BIDDERS.

- 8.1 Unless the context otherwise required or expressed, the terms not defined in this RFP shall have the meaning assigned thereto in this RFP.
- 8.2 Bidders shall be responsible for careful examination of all Bid Documents. All the information necessary for the Bid shall be obtained at Bidders' responsibility and expense. Misrepresentation or misinformation does not justify bidder in any alteration of the submitted offer.
- 8.3 Language of document shall be English.
- 8.4 Bid currency should be in Maldivian Rufiyaa (MVR) only.
- 8.5 Each Bidder must submit only one proposal by itself. A Bidder who submits or participates in more than one proposal will be disqualified. If MGPL discovers or has a reason to believe that collusion exists among any/all Bidders, any/all such proposals will be rejected, and all participants in such collusion will be excluded from consideration for future proposals for the same work.
- 8.6 At any time prior to the Bid Due Date, MGPL may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the RFP by the issuance of Addenda. In order to afford the Bidders a reasonable time for taking an Addendum into account, or for any other reason, MGPL may, in its sole discretion, extend the Bid Due Date.
- 8.7 Agreement shall be drawn with the selected bidder and this document with all terms and conditions shall form part of the Subsequent Agreement.
- 8.8 Notwithstanding anything to the contrary contained in this RFP, the detailed terms specified in the Subsequent Agreement shall have overriding effect; provided, however, that any conditions or obligations imposed on the Bidder hereunder shall continue to have effect in addition to its obligations under the Agreement.
- 8.9 Deadline for submission of Proposal may be extended at the discretion of MGPL.
- 8.10 Proposal submitted after the deadline shall be rejected.
- 8.11 Bids received by MGPL after the specified time on the Bid Due Date shall not be eligible for consideration and shall be summarily rejected.
- 8.12 Documents shall be sealed and Proposal Envelopes shall bear the following Identification

- 8.13 If the envelope is not sealed and marked as above, MGPL will assume no responsibility for the misplacement or premature opening of the proposal.
- 8.14 Any condition or qualification or any other stipulation contained in the bid shall render the Bid liable to rejection as a non- responsive Bid
- 8.15 The Bidder should submit a Power of Attorney as per the format in Annexure III authorizing the signatory of the bid to commit the bidder
- 8.16 Proposal will be opened at the presence of the bidders who choose to attend
- 8.17 The Letter of Award Notification (LOA) shall be sent to the Selected Bidder within the validity date of the Bidding process.
- 8.18 MGPL will review each bid and perform a detailed evaluation based on the evaluation criteria described in this RFP document.
- 8.19 MGPL reserves the right to accept or reject any Bid, and to annul the bidding process and reject all Bids at any time prior to Contract award, without thereby incurring any liability to Bidder.
- 8.20 In the event where the prices received are above the prices anticipated or where the submitted Proposals are not representatives of the prices in the general market, MGPL reserves the right to negotiate / cancel the process.
- 8.21 Any and all travel and accommodation expenses related to this tender shall be arranged and paid by the Bidder.
- 8.22 The delay damages for the work / service is 0.05% (Point Zero Five) per day
- 8.23 The maximum amount of delay damages for the whole of the works / services is 15% (fifteen percent) of the assigned work / services respectively.
- 8.24 MGPL reserves the right to reject proposals from Blacklisted Customers and Legal Customers, including the Default Customers / Parties and it shall extend to STO and Subsidiaries of STO as well.
- 8.25 MGPL may disqualify any bidder as a consequence of failure on commitment or quality issues stated below considering the part engagements with MGPL. Bidders will not be disqualified for unintentional mistakes or actions which do not tantamount to intentional cheating. MGPL has the right to disqualify or blacklist the Bidders permanently or to suspend the Bidder for a certain period of time depending on the severity.
 - Intent to cheat.
 - Misrepresentation of facts in Bid Proposals.
 - Malpractices in supplies or services
 - Intentional Disclosure of MGPL confidential information
 - Bidder participates in bidding / Negotiations, wins the contract but subsequently does not execute the work.
 - Repetitive Quality issues in Supplies / Services provided to MGPL regarding past engagements.

- Unreasonable delays in deliveries or execution of services in the past engagements.
- Bidder's repetitive delays getting into contractual agreement with MGPL after winning a contract.
- Other violations of responsible business practices.
- Any other criteria as MGPL may deem appropriate in the interest of the organization or government in compliance with company policies and Laws of Republic of Maldives.
- 8.26 MGPL reserves the right to verify all statements, information and documents submitted by the Bidder in response to the [the RFP and/or the Bidding Documents] and the Bidder shall, when so required by MGPL, make available all such information, evidence and documents as may be necessary for such verification. Any such verification or lack of such verification, by MGPL shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of MGPL thereunder.
- 8.27 Bids shall be deemed to be under consideration immediately after they are opened and until such time MGPL makes official intimation of award/ rejection to the Bidders. While the Bids are under consideration, Bidders and/ or their representatives or other interested parties are advised to refrain, save and except as required under the Bidding Documents, from contacting by any means, MGPL and/ or their employees/ representatives on matters related to the Bids under consideration.
- 8.28 Without prejudice to the rights of the MGPL herein and the rights and remedies which the MGPL may have under this RFP Document or otherwise, if a Bidder is found to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, or after the submission or the execution of the Agreement, such Bidder shall not be eligible to participate in any tender issued by MGPL during a period of 3 (three) years.
- 8.29 A Bidder must not have a conflict of interest (the "**Conflict of Interest**") that affects the Bidding Process. Any Bidder found to have a Conflict of Interest shall be disqualified. In the event of disqualification, MGPL shall be entitled to forfeit and appropriate the Bid Security as mutually agreed genuine preestimated loss and damage likely to be suffered and incurred by MGPL and not by way of penalty for, *inter alia*, the time, cost and effort of MGPL, including consideration of such Bidder's proposal (the "**Damages**"), without prejudice to any other right or remedy that may be available to MGPL under the Bidding Documents or otherwise.

- 8.30 The Bidding Process shall be governed by, and construed in accordance with, the laws of Republic of Maldives and the Courts of Maldives in where MGPL has its head office shall have exclusive jurisdiction over all disputes arising under, pursuant to and/ or in connection with the Bidding Process.
- 8.31 To assist in the examination of responsiveness, evaluation, and comparison of bids, MGPL may, at MGPL's discretion, ask any Bidder to submit any documents (including and not limited to some mandatory documents which shall not affect the competitiveness of the process) for clarification and verification of the Bidder's Bid. Any document which affect the competitiveness shall not be accepted during the resubmission period. The Tender Committee has discretion to reject any document submitted during resubmission period, if found, which shall affect the competitiveness of the Tender process.
- 8.32 Withholding tax of 10% will be deducted from the gross amount of invoice value if a payment is made for any service rendered by the Bidders not registered in Maldives, non-residents of Maldives as defined in Income Tax Act of Maldives.
- 8.33 The bidder shall be responsible for all of the costs associated with the preparation in the Bidding Process. MGPL will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process

9. MANDATORY REQUIREMENTS.

- The bidder shall not be affiliated with a firm or entity
- Must provide a copy of the ownership registry or equivalent legal documentation confirming ownership of the proposed property
- A detailed floor plan showing the layout and dimensions of the proposed space. The floor plan must clearly indicate the total floor area and how it meets the specified range of 1200-2200 sqft. Additionally, it should show the location of utilities such as electricity supply points, water supply points, and the placement of toilets if available within the space.
- A detailed location outlined diagram on how the proposed location ensures easy accessibility for customers and vehicles with four wheels
- If the bidder fails to meet the mandatory requirements, the bid will be considered non responsive and would not be taken into evaluation.

MGPL may choose to accept a proposal which does not contain one or more of the documents listed above in this section 9.1 on the ground that information provided in another document or elsewhere in the proposal does satisfy the purpose for which the document is requested. In situation where documents are missing bidders would be requested to submit the required docuemnts before evaluation is held.

10. EVALUATION CRITERIA AS FOLLOWS.

11. EVALUATION GUIDELINES

- **11.1** MGPL will subsequently examine and evaluate the Bids in accordance with the provisions set out in this RFP.
- **11.2** Prior to evaluation of Bids, MGPL shall determine whether each Bid is responsive to the requirements of this RFP.
- 11.3 Marks shall be distributed on Pro-rata basis.
- 11.4 MGPL has the rights to disregard the bid if the prices are above the market price.

11.5 Proposed Monthly Rent (55 marks)

- a. The lowest monthly rent offered will achieve the highest marks in the evaluation.
- b. Higher monthly rent offers will receive marks in proportion to the lowest quoted rent.

11.6 Lease Duration (20 marks)

- a. The total highest lease duration offered will receive the highest consideration in the evaluation process.
- b. Offers with lower durations will receive marks in proportion to the highest quoted lease duration.

c. Preferably, lease durations closer to the preferred 10-year term with renewal options will be favored.

11.7 Floor Area (15 marks)

- a. The highest floor area offered within the range of 1200-2200 sqft will achieve the highest marks in the evaluation.
- b. Offers with smaller floor areas will receive marks in proportion to the highest quoted floor area within the specified range.
- c. Preferably, floor areas closer to the upper limit of 2200 sqft will be favored, provided they meet all other criteria.

11.8 Adequate visibility (5 marks)

- a. The offer with the highest level of visibility, with shop space from a corner of a road mentioned in the ideal location(s) ensuring broad exposure to potential customers, will achieve the highest marks in the evaluation.
- b. Offers with low visibility will not recieve marks.

11.9 Access to vehicles (5 marks)

- a. Offers providing easy and convenient access for vehicles with four wheels, such as cars and delivery vehicles, will achieve the highest marks in the evaluation.
- b. Locations with restricted or difficult access for such vehicles will not receive marks.
- c. Preferably, locations with no pre-existing parking zone(s) infront of the shop will be prioritized.

12. AWARD OF CONTRACT

After selection, a Letter of Award (the "LOA") shall be issued, in duplicate, by MGPL to the Selected Bidder and the Selected Bidder shall, within 10 (ten) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. In the event the duplicate copy of the LOA duly signed by the Selected Bidder is not received by the stipulated date, the next eligible Bidder may be considered.

MGPL will treat all information, submitted as part of the Bid, in confidence and will require all those who have access to such material to treat the same in confidence. MGPL may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/ or MGPL or as may be required by law or in connection with any legal process.
