2. Bid Evaluation Criteria

2.1 Proposal Cost: 70 points for the lowest price

$(\text{Lowest price} / \text{proposed price}) \times 70$

2.2 Delivery: 20 points for the lowest delivery period

$(\text{Lowest delivery period} / \text{proposed delivery period}) \times 20$

2.3 Experience: 10 points for the experience letters submitted.

Marks will be awarded based on the number of reference documents submitted. ONE mark will be awarded for each reference document, Reference documents within the past 05 years shall only be considered and the bidder shall not submit more than 2 references from the same company/institution.

- Pixel Pitch: In between 3mm to 5mm
- Brightness (After Calibration): 5000 nits
- IP Rating: IP65
- Operation Humidity: 10-90% RH Non-Condensing
- Installation of LED wall structure should be with cladding box cover
- Minimum warranty of two years
