### 3.1. Price:

- 3.1.1 Each bidder's price is used to identify their relative position on a 0 40 price scale. This is done by allocating the lowest priced bid 40 points and calculating the remaining bidder's score in relation to this scale.
- 3.1.2 Price percentage = 40 x (lowest price / bid price)

### 3.2 Delivery:

- 3.2.1 Each bidder's Delivery is used to identify their relative position on a 0-10 price scale. This is done by allocating the lowest Delivery bid 10 points and calculating the remaining bidder's score in relation to this scale.
- 3.2.2 Delivery percentage = 10 x (Lowest Delivery / Bid Delivery)

### 3.3 Warranty:

- 3.3.1 Each bidder's Warranty is used to identify their relative position on a 0-30 price scale. This is done by allocating the Highest Warranty bid 30 points and calculating the remaining bidder's score in relation to this scale.
- 3.3.2 Warranty percentage = 30 x (bid Warranty / Highest Warranty)
- 3.3.3 All bidders must provide minimum 3-Years Warranty (Parts and services) including on-site support service. DNR should receive the full right to open any Machin at a given time without warranty been voided hence these systems will contain for confidential information. If Parts warrant and services warranty are provided separately than the smallest date will be considered.

### 3.4 Authorization letter:

- 3.4.1 For Authorization letter 20% will be awarded
- 3.4.2 Should submit the <u>Manufacturer's Authorization Letter</u> to demonstrate that it has been duly authorized by the manufacturer to sell/service the products and services.

### 4. How bid document will be deemed invalid or disqualified

- 4.1 Department of National Registration shall confirm that the following documents and information have been provided in the Bid. If any of these documents or information is missing, the offer shall be rejected or deemed Invalid at evaluation stage.
