a) Price

- o The bidder shall quote for delivery to Male' Port, capital of Maldives. (CIF)
- o All items shall be quoted in the bid.
- Quotation shall indicate the unit price, total price for each item and total price of the quotation. The quotation shall separately indicate additional charges such as freight charges, insurance, taxes, etc.

b) Delivery Period

o The delivery period shall be stated in 'calendar days'.

o If the delivery period indicates 'ex-stock', or if the duration is not specified, it shall be taken same as the party offering the longest delivery period.

c) Payment Terms

- o The payment terms shall be stated in 'days or months', and the payments will be released in equal monthly instalments.
- No points will be given for payment terms if the bidder requests for Letter of Credit (LC).
- o A maximum of 15% of the entire project can be provided as an advance if requested in the bid, however, it cannot be tied to the project starting date.
- o For 15% Advance payment supplier have to submit bank guarantee letter

d) Technical Specifications

- All the relevant technical information including the brand must be stated in the bid.
- o The quoted brand of cables must be approved by Maldives Energy Authority (MEA).
- The awarded vendor must provide a sample to Fenaka Corporation upon signing the agreement.
