Terms of Reference

1- Introduction and Background

The Salary and Wages Advisory Board (SAWAB) was established on 1st May, 2019 by President Ibrahim Mohamed Solih, to initiate the work on determining a minimum wage system in the Maldives. The Board is currently engaged in the process of drawing up an evidence-based methodology to establish a minimum wage. In this regard, we are planning to conduct a nationwide assessment of business enterprises assessment to identify macro-economic implications and impact on competiveness and industry growth prospects.

The objective of this survey is to collect data on economic factors, employment structure, and components of salaries and wages of enterprises in Maldives. In addition, the survey is required to accumulate qualitative data such the viewpoints of enterprises on the current wages, establishment of a Minimum Wage system in Maldives and rate(s) to be allocated as Minimum Wage

2- Scope of Work

The survey will be covering three main sectors, which are Tourism, Construction and Wholesale and retail trade sector (inclusive of restaurants and café businesses). Furthermore, the survey will be conducted in highly populated islands with high density of economic activities, which includes Male' City, Addu City, Fuvahmulah City and other 7 selected islands.

3- Deliverables

Survey questionnaires (separately for three sectors), the sample size and list of the islands will be provided to the surveyors.

4- Duration of the consultancy

7- Application and Submission
