c) Payment Terms

- No points will be given for payment terms if the supplier requests for Letter of Credit (LC).
- A maximum of 15% of the entire project can be provided as an advance if requested in the bid, however, it cannot be tied to the project starting date.
- For 15% advance bid awarded party shall submit a bank guarantee letter along with a pro-forma invoice.

d) Technical Specifications

- All the relevant information including the brand shall be given to enable technical evaluation of the items quoted.
- Technical compliance letter will be required to enable technical evaluation.
- Feeder panel that does not comply with the attached requirements will be rejected during evaluation.

e) Quotation Validity

• Quotation should be valid for minimum of 60 (sixty) days from the date of quotation opening.

f) Bid Security Validity

- A bid security with minimum validity for 20 (twenty) additional days beyond the validity of quotation.
