Bid Information

Quotation shall indicate the following;

a) Price

- The bidder shall submit quotation on CIF basis to Male' port.
- All items shall be quoted in the bid.
- Quotation shall indicate the unit price, total price for each item and total price of the quotation. The quotation shall separately indicate additional charges such as freight charges, insurance, taxes, etc.

b) Delivery Period

- The delivery period shall be stated in 'calendar days'.
- If the delivery period indicates 'ex-stock', or if the duration is not specified, the delivery period shall be taken same as the party offering the longest delivery period.

c) Payment Terms

- The payment terms shall be stated in 'days or months', and the payments will be released in equal monthly instalments.
- No points will be given for payment terms if the bidder requests for Letter of Credit (LC).
- A maximum of 15% of the entire project can be provided as an advance if requested in the bid, however, it cannot be tied to the project starting date.
- For 15% advance bid awarded party shall submit a bank guarantee letter or an insurance policy from Maldives Monetary Authority registered insurance company along with a pro-forma invoice.
- 5% of the bid value will be held as retention payment till the due of warranty period.

d) Technical Specifications

- All the relevant technical information including the brand must be stated in the bid.
- The quoted brand of cables must be approved by Maldives Energy Authority (MEA).
- The awarded vendor must provide a sample to Fenaka Corporation upon signing the agreement.

e) Quotation Validity

• Quotation should be valid for minimum of 60 days from the date of quotation opening.

- Delivery: 30 points for the minimum days to deliver the items
 - o (Lowest delivery period / proposed delivery period) x 30
- Credit Period: 10 points for the maximum credit period
 - o (Proposed credit period / longest credit period) x 10
