

## Procurement of Cables

Fenaka Corporation Limited requests quotation from interested local and foreign companies for cables in accordance to the information below herewith.

### Bid Information

Quotation shall indicate the following;

#### a) Price

- The bidder shall submit quotation on CIF basis to Male' port.
- All items shall be quoted in the bid.
- Quotation shall indicate the unit price, total price for each item and total price of the quotation. The quotation shall separately indicate additional charges such as freight charges, insurance, taxes, etc.

**b) Delivery Period**

- The delivery period shall be stated in ‘calendar days’.
- If the delivery period indicates ‘ex-stock’, or if the duration is not specified, the delivery period shall be taken same as the party offering the longest delivery period.

**c) Payment Terms**

- The payment terms shall be stated in ‘days or months’, and the payments will be released in equal monthly instalments.
- No points will be given for payment terms if the bidder requests for Letter of Credit (LC).
- A maximum of 15% of the entire project can be provided as an advance if requested in the bid, however, it cannot be tied to the project starting date.
- For 15% advance bid awarded party shall submit a bank guarantee letter or an insurance policy from Maldives Monetary Authority registered insurance company along with a pro-forma invoice. .
- 5% of the bid value will be held as retention payment till the due of warranty period.

**d) Technical Specifications**

- All the relevant technical information including the brand must be stated in the bid.
- The quoted brand of cables must be approved by Maldives Energy Authority (MEA).
- The awarded vendor must provide a sample to Fenaka Corporation upon signing the agreement.

**e) Quotation Validity**

- Quotation should be valid for minimum of 60 days from the date of quotation opening.

**f) Packing List:**

- Awarded Vendor must pack cables as per below packing list otherwise cables will be rejected

### **Required Documents**

- Quotation (inclusive of the delivery period and the payment terms)
- 1 compact disc (original bid document scanned and written), along with 2 sets of the bid documents (1 original and 1 copy set) separately packed and sealed with company stamp.  
All the pages in bid documents should be stamped and bound properly
- Specification of the offered product
- Original bid security (as per announcement)
- Details of the company
  - Company profile (a background of the company)
  - Company registration certificate
  - GST registration certificate (for local suppliers only)
  - Tax clearance report (6 months validity)
  - Contact details (name, designation, mobile number, e-mail address)
- Experience letters (letters beyond 5 years / irrelevant experience letters / letters without project and value will not be accepted)

### **Evaluation Criteria**

- Proposal Cost: 50 points for the lowest price
  - $(\text{Lowest price} / \text{proposed price}) \times 50$
- Delivery: 30 points for the minimum days to deliver the items
  - $(\text{Lowest delivery period} / \text{proposed delivery period}) \times 30$
- Credit Period: 10 points for the maximum credit period
  - $(\text{Proposed credit period} / \text{longest credit period}) \times 10$



- Experience: 10 points  
(Point will be given by analyzing related experience letters of past 5 years depending on the value of the project)

**Note:**

- Bidders can submit maximum of 2 options.
- Bids lacking the documents above are subjected to be rejected during bid opening. Fenaka Corporation Limited will only accept items that meet OEM standards. In case the items do not meet the required standards, they will be rejected / returned.
- Please make sure the items are properly packaged and labelled separately as specifications given above.
- It is in Fenaka Corporation Limited's discretion to reject/cancel any quotation which does not fulfil or comply the above terms.
- It is in Fenaka's discretion to cancel this invitation to bid at any time.
