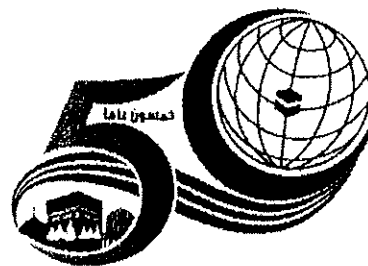

**Conditions and rules of participation**

1. Participating countries shall bear the full expenses of participation of the members of their artistic delegations.
2. Need for participating bands to adhere to the event programme and the schedules of folklore shows.
3. Participating countries shall bear the shipping expenses of any equipment or material needed for folklore shows or exhibits and their shipping back to the country of origin after the end of the event.

4. Handicrafts are only for display and not for sale. Food will also be offered to the public free of charge.
5. Need to provide an overview of participating bands and a clear color photograph of every band in its traditional costume.
6. The officials of the host country and the General Secretariat may select high quality and convenient bands and exclude bands, which are not commensurate with the level of the event.
7. Participation will be confirmed through focal points in every country once the required documents and photographs are received and reviewed.
8. The deadline of acceptance of participation forms is **Sunday 3 November 2019**.
9. All participating bands should abide by the laws and regulations in force in the host country, the Kingdom of Saudi Arabia.
