## Section I: Instruction to Bidders

<b>A. General</b>	
<b>1. Scope of Bid</b>	<p>1.1 Fenaka Corporation Limited requests quotations of 4 Ton sewerage suction and water jetting truck in accordance with Section III: Bid Document, and all bidders are required to submit quotations in full conformity with these specifications.</p> <p>1.2 Fenaka Corporation Limited reserves the right to cancel this bid invitation, at any stage prior to award, if deemed to be in the best interest of the Company. In such an event, bidders will be formally notified in writing.</p>
<b>2. Eligible Participants</b>	<p>2.1 Participation in this tender is strictly limited to Original Equipment Manufacturers (OEMs) of the filters. No other parties will be considered. Local and foreign bidders must submit a certificate of manufacturer (for OEMS).</p> <p>2.2 Local bidders must be legally registered in the Maldives and shall provide a valid company registration certificate, GST registration certificate, and a current tax clearance certificate.</p> <p>2.3 Foreign bidders must be legally registered in their country of origin and shall provide official company registration documents issued by the relevant government authority. All company registration documents submitted by foreign bidders must be notarized by a licensed Public Notary in the country of origin.</p>
<b>B. Preparation of the Bid</b>	
<b>3. Bid Prices</b>	<p>3.1 Bidders shall clearly state both the unit price of each item and the overall total price in their quotation.</p> <p>3.2 Bidders must submit quotations for all items listed in Section III: partial or incomplete bids will not be accepted.</p> <p>3.3 All bids shall be quoted on a CIF Male' Port basis, inclusive of all applicable duties, taxes, and charges up to delivery at Male' Port.</p>
<b>4. Currency</b>	<p>4.1 Local bidders shall quote prices entirely in Maldivian Rufiyaa (MVR).</p>

	<p>4.2 Foreign bidders shall quote their prices entirely in United States Dollars (USD). For evaluation purposes, all foreign currency quotations shall be converted into Maldivian Rufiyaa (MVR) at the official exchange rate published by the Maldives Monetary Authority (MMA) on the date of bid submission.</p>
<b>5. Alternative Bids</b>	<p>5.1 Each bidder shall submit only one (1) bid in response to this tender. Submission of multiple or alternative bids by the same bidder will not be accepted.</p>
<b>6. Validity of Bids</b>	<p>6.1 Each bid shall remain valid for a minimum of sixty (60) days from the date of bid opening.</p>
<b>7. Technical Compliance</b>	<p>7.1 Technical evaluation will be conducted solely based on written documents submitted by the bidder, and incomplete or missing submissions will result in disqualification.</p> <p>7.2 Technical compliance letters will be required to enable technical evaluation</p> <p>7.3 Any bid failing to demonstrate compliance with Section III: shall be rejected as non-responsive.</p>
<b>8. Documents Comprising the Bid</b>	<p>8.1 The bid shall include the proposed delivery period and payment terms.</p> <p>8.2 Detailed technical specifications of the offered product in accordance with Certificate of Authenticity confirming that the manufacturer/assembler is an OEM of a genuine or, for authorized distributors, a valid Certificate of Sole Distributorship issued directly by the manufacturer.</p> <p>8.3 Bowser truck photo (Color photo)</p> <p>8.4 Company details, which shall include,</p> <ul style="list-style-type: none"> <li>- Company profile and background information</li> <li>- Company registration certificate</li> <li>- Memorandum of Association / Articles of Association</li> <li>- GST registration certificate (for local bidders only)</li> <li>- Valid Tax Clearance Report (issued within the last six months)</li> </ul>

The electronic version must be identical to the signed and stamped hard copy. In the event of inconsistency, the hard copy shall prevail.</p> <p>Any bid failing to comply with the above requirements or lacking any of</p> <p>8.7 the mandatory documents listed under Section 7 (Technical Compliance), shall be rejected as non-responsive and excluded from further evaluation.</p>
<p><b>9. Format of Bid</b></p>	<p>9.1 Every page of the bid document shall be signed by the authorized signatory of the company, stamped with the company seal, and sequentially numbered. All required sections and annexes must be clearly indicated and properly arranged. Bids failing to comply with this requirement may be rejected as non-responsive.</p>

C. Bid Submission	
<b>10. Sealing and Marking Bid Document</b>	<p>10.1 Local bidders shall submit two (2) complete sets of the bid document: one (1) original and one (1) copy. Each set shall be enclosed separately in its own sealed envelope, clearly marked as “ORIGINAL” or “COPY.” The sealed envelopes shall then be placed in a single outer envelope, which shall be sealed and clearly marked with the tender reference number (<b>FNK-I/IUL/2026/082</b>) and the name of the bidder. In the event of any discrepancy, the signed and stamped “ORIGINAL” version shall prevail.</p> <p>10.2 Foreign bidders may submit their bids electronically via the official tender email address specified in <u>Section I, Clause 11.4</u>. The bid documents must be encrypted with a password, and the password must be submitted separately within the specified time window on the day of bid opening. The subject line of the submission email shall include the tender reference number (<b>FNK-I/IUL/2026/082</b>). Any bid or password received after the specified time shall not be accepted.</p>
<b>11. Bid Submission Deadline: **Encrypted bid documents must be emailed on the same day as the bid opening 30 minutes before 1300hrs (Maldivian time).**

Password Submission Deadline: **Passwords must be emailed between 13:00hrs to 13:15hrs.**

The electronic bids and the passwords received after **13:15hrs** will be rejected.

- Foreign bidders are required to be present via online video call during the bid opening (**Camera is a must**).
- The link for the bid opening session will be provided to foreign bidders 15 minutes before the bid opening.
- Foreign Bidders shall be online in the bid opening meeting at **13:00hrs (Maldivian time).**
- Failure to attend the bid opening session virtually at the Mentioned time will result in the rejection of the bid.
- **Each Bid shall have different passwords.**
- Foreign bidders submitting electronically shall dispatch the original physical bid documents to Fenaka Corporation Limited Head Office within seven (7) calendar days from the date of opening.
- Bidders shall provide verifiable tracking details (e.g., courier or postal service tracking number) by email at the time of dispatch, as proof of timely submission of the original documents.

Bid Rejection</b></p>	<p>12.1 Bids received after the submission deadline shall not be accepted or opened.</p> <p>12.2 Bidders that fail to complete the mandatory registration process for this tender shall not be eligible to participate.</p> <p>12.3 Bids lacking any of the mandatory documents listed under Section 8 (Documents Comprising the Bid) or not prepared in accordance with Section 9 (Format of Bid), shall be rejected as non-responsive.</p>

<p><b>13. Payment Terms</b></p>	<p>13.1 No advance payment shall be made under this contract.</p> <p>13.2 Vehicles should be in alliance with Ministry of Transport and Civil Aviation vehicle registration regulations.</p>
