3. A minimum warranty period of **one (1) year** shall be provided for all items.

6 Language:

The bid must be drafted in English

- 7 **Price:** All prices shall be submitted in **United States Dollars (USD)** and shall be inclusive of all applicable costs.

Bidders are required to provide the following:

- 7.3 Unit price and total price for each item (each item must be quoted separately).
- 7.4 Total bid price for all items.
- 7.5 The Bidder shall be fully responsible for all costs, charges, and risks associated with the delivery of the items.

8 Packing and delivery

8.1 The Bidder shall be fully responsible for the safe delivery of all items to Maldives Post Limited, Malé, Maldives, including all costs related to transportation, freight, insurance, loading, unloading, and any other logistical arrangements required for delivery.

8.2 Delivery shall be completed within the timeframe specified in the contract. Any anticipated delays must be communicated to Maldives Post Limited in writing without delay.

8.3 Partial deliveries shall not be made unless prior written approval is obtained from Maldives Post Limited.

Risk of loss or damage to the goods shall remain with the Supplier until formal acceptance of the delivered items by Maldives Post Limited.

9 Validity:

Bids shall be valid for at least **four months** after the closing date of the call for tenders.

10.1 Price (40%)

Bids will be evaluated based on the total proposed cost of the project. Competitive pricing is essential to ensure value for money.

10.2 Product Features (25%)

Full marks will be awarded to bidders whose proposed items fully meet the required technical specifications.

10.3 Delivery Period (15%)

Evaluation will be based on the proposed delivery timeline. Shorter delivery periods will receive higher scores relative to other bids.

10.4 Experience (10%)

Bidders must submit a minimum of three (3) project reference letters from organizations confirming successful completion of similar projects, including relevant contact details.

10.5 Maintenance & Support (10%)

Full marks will be awarded to bidders who provide comprehensive after-sales service, including maintenance and technical support.

11. Mandatory Documents to submitted

- Company profile and registration certificate
- GST Registration Certificate
- Proposal quotation
- Last 2 years financial statements
- Reference letters from previous project clients, including relevant referees and contact details.
- Parties who are submitting combined bids/proposals shall submit details of third party.
- Declaration on ethical conduct and fraud and corruption agreement (attached with email)
- MIRA tax clearance letter dated not longer than 3 months from date of bid submission

12. Bid Rejection;

Bids may be rejected for the following reasons:

- Submitting false information or documents.
- Quoting excessively high prices.

- Failure to submit any of the mandatory documents listed under bid submission requirements.
- Submitting low-quality or incomplete proposals.
- Failing to meet the defined technical or project requirements.
- Failing to submit a declaration on ethical conduct and the fraud and corruption agreement.
