TERMS OF REFERENCE (TOR)

Expression of Interest & Selection: Official Accommodation Partner(s) Islamic Economic Training Camp 2026

1. Background & Purpose

The Islamic University of Maldives (IUM) is organizing the Islamic Economic Training Camp (IETC), scheduled to take place from September 08th, 2026, to September 13th, 2026. To ensure high-quality accommodation services for the participants, IUM invites interested service providers and hotel/B&B properties to submit proposals to serve as an Official Accommodation Partner for IETC.

2. Scope of Work & Deliverables

The selected Accommodation Partner will enter into a formal partnership agreement with IUM under the following obligations and terms:

A. Booking & Administrative Support

- Reserve, track, and manage all room allocations and participant bookings under the official event name: "IETC".
- The awarded vendor must provide booking confirmation documentation to IUM before the scheduled stay date. The scheduled stay dates and details are as follows:

B. Accommodation Allocation & Pricing

- IUM-Billed Rooms: Provide 6 (six) standard twin/bed rooms in Male' and 30 room in K. Thulusdhoo. All room charges for these specific rooms will be billed directly to IUM.

3. Key Terms & Governance

- **Amendments:** Any modifications to the final agreement must be mutually agreed upon in writing and signed by authorized representatives of both parties.
- **Jurisdiction:** Governed by the laws of the Republic of Maldives. Unresolved disputes will be handled through mutual discussion or submitted to the relevant court of law in the Maldives.

4. Marking Criteria

A. Price: 80%

- The calculation for the price will be determined using the following formula. Marks will be given
 - $\text{Lowest rate submitted} / \text{submitted price} \times 80\%$

B. Additional Services: 20%

- Vendors are welcome to propose additional services within the room rate. Each additional service will be granted 1 point. The maximum points that will be given for this criterion is 20.
