- 1) If, after Bid opening, the bidder withdraws his Bid during the period of Bid validity specified in the form of Bid; or
- (2) If the bidder having been notified of the acceptance of his bid by the Purchaser during the period of Bid validity:
 - (a) fails or refuses to execute the Form of Agreement in accordance with the instruction to the Bidders, if required; or
 - (b) fails or refuses to furnish the performance Security, in accordance with the instruction to Bidders; or
 - (c) does not accept the correction of the bid pursuant to Clause 27.

We undertake to pay to the Purchaser up to the above amount upon receipt of his first written demand, without purchaser’s having to substantiate his demand, provided that in his demand the Purchaser will note that the amount claimed by him is due to him owing to the occurrence of one or any of the three conditions, specifying the occurred condition or conditions.

This Bond will remain in force up to and including the date (----- Date-----) 90 days after the deadline for the submission of bids as such deadline is stated in the instructions to the Bidders or as it may be extended by the Purchaser, notice of which extension(s) to the Insured is hereby waived. Any demands in respect of this bond should reach the insurer not later than above date.

This Bond shall be governed by and constructed in accordance with the laws of the Republic of Maldives.
