#### **INVITATION TO BID**

Island Aviation Services invites bid proposals valid for 60 days from the date of opening the bids from Maldivian and international companies, for procuring requirement as per the RFB. All bidders are advised to study the Bid Document carefully.

Date and time for submission of bids: 6th June 2020, between 09:00 hours to 12:00 hours (Local Time) via email to the mentioned mail addresses in the RFB.

Any Bids submitted before or after the time period mentioned above will NOT be accepted.

## **Services/Goods Required**:

Supply of Quantity 14 (fourteen) 40 Feet ISO Container Tanks for Jet A1 as per the specification mentioned in the appendix A and B.

Bidders would be allowed to propose for either the stainless steel or steel 304 tank materials or for both options.

### Eligible bidders

The Bidders must submit relevant documents as per clause (s) of this document.

- a. Vendor can be a local or international firm or individual providing such services as per attachment.
- b. Local parties must have it's own operational office or representative at Maldives and registered with Maldives Inland Revenue Authority (MIRA)
- c. The Bidder shall furnish the following documentary evidence.
  - If vendor is a firm, Profile of the Firm including the firm's shareholding structure and details.
  - Record(s) of similar projects carried out by the firm in the last three or Five years.
  - A letter stating if the bidder has or does not have any relationship in terms of employment or close family relationship. Close family relationship here refers to spouse, including former spouse relatives, which comprise: siblings; cousins; uncles and aunts; nephews and nieces; lineal ancestors (presumably, it means parents, grandparents and other ancestors of direct lineage) lineal descendants (children, grandchildren and other direct descendants).

- d. Prospective bidder requiring any clarification on the bidding documents and requirements may notify Island Aviation Services Ltd (IASL) in writing to <a href="mailto:rfp.pss@iasl.aero">rfp.pss@iasl.aero</a> copied to <a href="mailto:hussain.safuath@iasl.aero">hussain.safuath@iasl.aero</a> and all queries and clarifications must be emailed prior to 5 days to the date of bid submission.
- e. All information provided will be subjected to verification by IASL. Submission of incomplete or unsigned forms will result in rejection of the bid as non-responsive.
- f. The CIF price must be quoted in United States Dollar (USD) or Maldivian Rufiyaa (MVR) inclusive of all taxes.
- g. Bid must remain valid for a period of 60 days after the date of Bid submission
- h. The bidder must submit the bids via email to <a href="mailto:rfp.pss@iasl.aero">rfp.pss@iasl.aero</a> copied to hussain.safuath@iasl.aero
- i. If less than two bids have been submitted, IASL has the right to continue or reject the evaluation or request for a resubmission.
- j. If any of the documents mentioned are missing from the Bid the company has the right to reject the evaluation or request for a resubmission
- k. IASL will only accept one bid document from every bidder.
- 1. To assist in the evaluation and comparison of bids, IASL may, at its discretion, request any bidder for clarification of its bid. This will be clarified in writing, but no change in substance or price of the bid will be sought.
- m. IASL will evaluate and compare only those bids determined to be responsive in accordance with requirements specified in the bidding document.
- n. IASL will award the contract in writing to the bidder who scores the highest marks in compliance with the criteria decided by the Tender committee.
- o. Upon furnishing by the successful bidder, IASL will promptly notify the other bidders through telephone or email that their bids have been unsuccessful.
- p. IASL intends to apply the following criteria for the selection of bids. The Bid will be evaluated by the procurement committee of IASL. Points will be given to proposals according to the evaluation criteria below.

Price Offered - 75%
Delivery Period - 15%
Past Experiences - 10%

Note: The preferred delivery period is 1 month. Full marks for the delivery period will be awarded to bidders who meets the preferred delivery period.

q. Following are to be submitted with the bid proposal. Failure to do so may result in disqualification from the bid.

#### 1. COVER LETTER

• The cover letter for the proposal must be signed by an authorized person who has the authority to bind the Bid to a Contract.

• If vendor is a firm, Profile of the Firm including the firm's shareholding structure and details.

- Provide information about the bidders capacity and experience of similar projects.
- Provide recent financial statements (audited, 2018 or 2019), to indicate financial strength of the company to execute a project of this nature.
- List of past experience in similar projects with letters of completion. If past experiences are not accompanied with an official letter of completion marks will not be awarded to that section.
