## SCHEDULING OF BADMINTON COURTS FOR REGISTERED CLUBS & INDIVIDUAL MEMBERS.

- 1. Scheduling of Ekuveni indoor Badminton courts other than the scheduled timings allocated for Association pools will be available on Request from 1<sup>st</sup> of July 2020 onwards for Clubs and individuals registered as Members with badminton Association who have paid the Membership fee for the 1<sup>st</sup> Quarter of 2020.
- 2. Members who have paid this year's 1<sup>st</sup> Quarter Fee are not required to pay for the 2<sup>nd</sup> Ouarter.
- 3. As Courts will be Scheduled for Registered Members only, all members are Required to have the Membership card when attending the Scheduled timings allocated on Request & may not be allowed to enter the Hall without the Valid Membership Card issued for 2020.
- 4. Members are allowed to play in non-marking silicon layered badminton indoor shoes only, those who fail to comply with the request may not be allowed to use the Courts.
- 5. Playing Shoes should only be worn after entering the Hall or court area.
- 6. Requests should be made one day prior to the day Members wish to schedule.
- 7. Maximum number of Players allowed & allocated for a court will be 8 Members/Players.
- 8. Individual Members are Recommended to Request as a Group of Minimum 6 players or Maximum 8 players (with Valid Membership of 2020)
- 9. Scheduled Court time allocated will be 90 minutes (including warmup etc.)
- 10. All Members are strictly advised to be present for their scheduled timings only & should vacate the court Area and premises right after their allocated timing in order to make way for the next scheduled Group of Members.
- 11. Courts will be scheduled the next day based on Requests received on the present day between 9:00am to 02:00pm only & will be published in Badminton Association Viber Community and Notice Board outside Ekuveni indoor Badminton Hall-
- 12. Hall will be Closed for Members during the Association Pool timings allocated & Scheduled.
- 13. Key Measures to be Considered at all times:
  - Physical distancing / wear masks
