# SECTION B INSTRUCTION TO BIDDERS

## **1- Introduction**

The purpose of this Request for Proposal (RFP) is intended for competitive vendors who are interested to bid for Supply, Installation and Commissioning of TradeNet Data Center Servers, Firewall ad PBX Solution for TradeNet Maldives Corporation Limited. This RFP provides vendors with the bill of materials, technical compliances and architectural requirements for successful responses.

The vendor is requested to give technical and commercial proposals in accordance with the terms and conditions mentioned in this document.

The bidder is expected to examine all instructions, forms, terms and technical specifications in the bidding documents. Failure to furnish all information or documentation required by the bidding documents may result in the rejection of the bid.

TradeNet Maldives reserves the right to refuse entry into any contract, to add to and/or delete, or to change any element of the coverage and participation at any time without prior notification and without any liability or obligation of any kind or amount.

All RFP's must be valid for a period of 90 Days from the date of submission.

## 2- Communication

Applicable terms and conditions herein shall govern communications and inquiries related to this RFP between TradeNet Maldives and vendors.

Any other form of communication shall be considered informal and shall have no weight, bearing, or influence in this RFP process.

## **3- Qualified Bidders**

Any single firm (sole proprietorship, partner, corporation, or other legal entity registered in the Republic of Maldives) is welcome to participate.

#### 4- Vendors understanding of the bid

In responding to this RFP, the vendor accepts full responsibility to understand the RFP in its entirety, and in detail, including making any inquiries to TradeNet Maldives as necessary to gain such understanding.

TradeNet Maldives reserves the right to disqualify any vendor who demonstrates less than such understanding. Further, TradeNet Maldives reserves the right to determine, at its sole discretion, whether

the vendor has demonstrated such understanding. That right extends to cancellation of award, if award has been made. Such disqualification and/or cancellation shall be at no fault, cost, or liability whatsoever to TradeNet Maldives.

## **5- Proposal Requirements**

#### **5.1 Pre-Qualification Requirements**

The Bidder must have been in the service of this nature/IT Solutions for past five (5) Years in related to supply, configuration and commissioning of IT solutions.

#### 5.2 Proposal Format

The Bid document shall be rejected if it fails to meet the following minimum criteria and submit the required documents.

The complete original proposal must be submitted in a sealed package. Bid shall be marked

"Supply, Installation and Commissioning of TradeNet Data Center Servers, Firewall and PBX Solution".

Bidder shall file all documents necessary to support their proposal and include them with their proposal.

- A summary of the Proposer's document and approach to the installation of systems of this kind and identify any unique or distinctive features of the system of particular interest to the evaluators based on the needs specified in this document
- The proposer must provide basic information on the proposer and any partners or subcontractors participating in the tender. This information should include, but not limited to, the history of the organization, its experience and its experience in the IT field, technical capabilities, experience implementing similar architecture, the size of implementations and success stories. This section should also explain any partnering arrangements that have been made to respond to the proposal.
- Proposal shall be submitted in the following format and include the following information:
  - Detailed description of proposed equipment/services including the manufacturer part numbers, scope of work and quotation shall be submitted.

 Bidder that does not manufacture or produce the goods it offers to supply shall submit the Manufacturer's Authorization Letter, to demonstrate that it has been duly authorized by the manufacturer or producer of the goods to supply these goods in the Republic of Maldives.

- It is mandatory that the bidder will maintain the required technical team as deemed as suited based on the requirements and milestones. However, TradeNet Maldives expects that the proposer would have allocated the following or more team compositions having specific skill sets and professional experience. Importantly it is expected that the proposer will maintain necessary resources on-site during crucial stages of the project that requires closer interaction with TradeNet Maldives during installation, configuration, integration, On-the-Job training, etc. The Bidder MUST have at least One (1) full time trained service personnel under its payroll for Server, Vmware, Microsoft, Firewall and 3CX. The bidder shall attach the professional certificate of the engineer for reference. The bidder shall submit the following documents:
  - Certification copy of the relevant training
  - NID / Passport copy of the engineer
  - Contact of the engineer or a focal point from the company
- Unless otherwise specified, the Bidder shall quote entirely in Maldivian Rufiyaa.
- Evidence of the bidder's financial, technical and organizational capability and experience to perform the Contract

## 6- Delivery & Installation

The successful bidder shall deliver the goods within **15** Day(s) upon signing of the contract.

The successful bidder shall complete the installation within **5** Day(s).

## 7- Warranty

- Server and Firewall: Three (3) Years 24x7 Hardware replacement and on-site support with Software Technical Support
- Software such as Vmware and Microsoft: One (1) Years 24x7 software Subscription and Technical support
- 3CX PBX: One (1) Year 24x7 software Subscription and Technical support

The Successful Bidder shall provide a warranty that the solution (software, hardware, etc) provided under the contract will comply strictly with the contract, Shall be genuine(Factory integrated) in every particular case and shall be free from defects.

The Successful Bidder further warrants to TradeNet Maldives that all materials, equipment and supplies furnished by the vendor will be new, merchantable of the most suitable grade and fit for their intended purposes.

The warranty period, shall be as given in the bid proposal and/or otherwise agreed in conditions of contract between TradeNet Maldives and the Successful Bidder. Additionally, the Successful Bidder further warrants that all materials and equipment furnished are supplied from authorized channels.

TradeNet Maldives reserves the right to reject the goods if it is identified as grey market products or counterfeit equipment.

## 8- Evaluation and comparison of bids

- a) Clarification of Bids: To assist in the examination, evaluation, comparison and postqualification of the bids, TradeNet Maldives may, at its discretion, ask any bidder for a clarification of its bid. Any clarification submitted by a bidder in respect to its bid and that is not in response to a request by TradeNet Maldives will not be considered. No change in the prices or substance of the bid shall be sought, offered, or permitted, except to confirm the correction of arithmetic errors discovered by TradeNet Maldives in the evaluation of the bids.
- b) Responsiveness of Bids: If a bid is not substantially responsive to the Bidding Documents, it shall be rejected by TradeNet Maldives and may not subsequently be made responsive by the bidder by correction of the material deviation, reservation, or omission.
- c) Technical evaluation of Bids: TradeNet Maldives shall evaluate the technical aspects of the Bid submitted in accordance with the RFP, to confirm that all requirements specified in the RFP have been met without any material deviation or reservation.

#### Price:

Each bidder's price is used to identify their relative position on a 0 - 60 price scale. This is done by allocating the lowest priced bid 60 points and calculating the remaining bidder's score in relation to this scale. Price percentage =  $60 \times (lowest price / bid price)$ .

#### Experience:

Proof of supply and installation of similar system to other organizations within last five (5) Years. (Bidder should submit purchase orders or letter from user organization mentioning successful implementation.)
