 - c. A detail proposal as per the requirement detail given on this RFP.
 - d. A letter stating if the vendor has or does not have any relationship in terms of employment or close family relationship with IASL management. Close family relationship here refers to spouse, including former spouse relatives, which comprise: siblings; cousins; uncles and aunts; nephews and nieces; lineal ancestors (presumably, it means parents, grandparents and other ancestors of direct lineage) lineal descendants (children, grandchildren and other direct descendants).
- e. Company registration certificate

- f. GST registration certificate
- g. Reference letter of relevant services provided for other clients.
- h. Proposal must remain valid for a period of 60 days.
