Purchase of Uniform T-Shirts



Company Overview

Bank of Maldives (BML) is the leading bank in Maldives. Known locally as "the national bank", BML is a public limited company with majority ownership held by the Government of Maldives.

Objectives & Scope of Request for Proposal

As per the Bank's Staff Uniform Guideline, the Bank has been distributing uniform T-shirts semi-annually to all staff. The uniform T-shirts are usually purchased and distributed in two batches. Hence the Bank seeks a vendor that is able to provide the required uniform T-shirts as per the current design specifications.

About the Proposal

BML is looking for a vendor that can provide uniform T-shirt as per the Bank's requirements whereby the delivered uniforms are of good quality and are delivered in a timely manner. It is recommended to find a vendor through open bidding process which is open for both local and international vendors. From the submissions, the evaluation committee will select one submission based on the criteria mentioned below. This selected vendor must be able to provide sample uniforms that will be further evaluated. Once the sample has been approved, the vendor will be instructed to produce the orders as per the Bank's quantity requirements.

Evaluation of the Design and Sample

In addition to the technical drawings (Annexure 1), the following minimum requirements must be fulfilled by the selected vendor:



Quantity:

The Bank requires a total of 4,000 T-shirts for the year and will be requested in 2 batches during the middle of the year and beginning of the year. Bidding vendors must be able to provide quantity as per delivery period upon placement of the orders.

Sample

The selected vendor will be required to produce 3 sample uniform T-shirts:

- Short Sleeve Male
- Short Sleeve Female
- Long Sleeve Female

The prepared samples will be inspected and reviewed by the Bank. Once the sample has been approved, the vendor must supply uniform T-shirts of equal quality or better during the production of each batch of uniforms.

Uniform:

Uniform design, color and specifications as to be provided as per the technical drawings and size chart (Annexure 2). Additional requirement details below:

- Color: Red.
- Fabric: 95% cotton, +5% elastane, plain weave.
- Collar ribs, silk embroidered for Bank of Maldives name and Logo.
- Logo and name placements as per technical drawings.

Reference/ Experience Letters:

Bidding vendors must provide at least 2 reference letters as proof of experience in providing corporate uniform T-shirts to offices or Companies. These letters must indicate that the vendor has supplied more



than 1000 uniform T-shirts to these parties during the contract period, and must not be dated more than 3 years.

1. Price

Lowest bid obtains full marks.

2. Delivery Period

Bidding vendors must mention the delivery duration for each order of uniform T-shirts. Parties will score full 20% if they are able to deliver both the sample and batch productions within the required delivery period.



Terms and Conditions

Confidentiality

The proposal shall be held in strict confidence and not be revealed to any other party. Any information pertaining to Bank of Maldives PLC as a result of participation shall not be disclosed without the prior written consent of the Bank.

Evaluation of the offers

The evaluation of the proposals will be based on the evaluation criteria. The issuance of RFP document is an invitation to offer and must not be construed as any agreement or contract or arrangement nor would it be construed as material for any investigation or review to be carried out by a vendor.

Quotations

All prices must be quoted as per the requirements set out in this document. The quoted prices must be valid for at least 90 days.

Purchase Orders

Please note that we may purchase all the items, selected items, or none of the items, based on comparative offers from different vendors.

Fines for late delivery

Fine for late delivery/completion will be charged 2% per day and if the items are not completed within the agreed period, the Bank has the right to cancel the contract.

Acceptance of terms

The Recipient will, by responding to the Bank's RFP document, be deemed to have thoroughly read the whole RFP document and unconditionally accepted the terms and conditions as stated.

Request for clarifications should be submitted via email to openbidding@bml.com.mv before 14:00hrs (local time) on Wednesday, 03rd March 2021.

Submission of Proposal

All submissions should be e-mailed to openbidding@bml.com.mv before 14:00hrs (local time) Wednesday, 31st March 2021 OR by visiting Bank of Maldives, H. Zoneria, Meeting Room, 1st Floor, 14:00hrs (local time).

It is the proposer's responsibility to ensure that the Bank receives the proposal on or before the deadline. Any proposal received after the closing time and date of submission shall not be considered.






