Important Notice

1. This is not an invitation to tender. Full tendering procedure will be communicated to contractors prequalified and found capable of executing the project.
2. Contractors who score more than **70%** will only be qualified and communicated for the tender process
3. Maximum advance payment term should be limited to 15%
4. Relatively a higher mark will be allocated for long term payment offer during the tendering process.
