#### **Terms of Reference for**

## SUPPLY AND DELIVERY OF CORRUGATED PIPE FOR MALE' STREETSCAPING PROJECT

#### **BACKGROUND**

Road Development Corporation Limited (RDC), an incorporated limited liability company operating under the registration number C10482019 and having its registered office at MSL Building, First Floor, Malé, Republic of Maldives (herein after called and referred to as "the Employer",) invites sealed tenders from eligible bidders for supply and delivery of corrugated pipes for Male' Streetscaping Project (hereinafter called the "Works" or "Project")

#### SCOPE OF WORK

The scope of Works shall include supply and delivery of accurate quantity of corrugated pipes to RDC site within the Greater Male' area. The quality of supplied materials must meet the technical specifications outlined in the appendix attached.

It is the supplier's responsibility to bear all the cost involved in the supply and delivery of the corrugated pipes (including clearance expenses, logistics, duty fines, and other expenses).

Bidders must include the specifications of the proposed products. The Employer have the right to reject any proposals submitted without the proposed product's specifications
