**Terms of Reference for
SUPPLY AND DELIVERY OF RAW MATERIALS FOR GDH. GAHDHOO MAJOR ROADS
PROJECT**

Date: 28 June 2021

1. BACKGROUND

Road Development Corporation Limited, an incorporated limited liability company operating under the registration number C10482019 and having its registered office at MSL Buildings, First Floor, Malé, Republic of Maldives (herein after called and referred to as “the Employer”), invites sealed tender from eligible bidders for supply and delivery of raw materials for GDh. Gahdhoo Major Roads project (hereinafter called the “Works” or “Project”).

2. SCOPE OF WORK

The Employer will finance the supply and delivery of raw materials for GDh. Gahdhoo Major Roads project. The scope of Works shall be as follows.

- Provision of the following documents with all consignments.
 - The manufacturer’s details and specifications of the material.
 - Manufacturer’s test certification for all consignments.
 - Third party test reports.
- **Above documents must be submitted if the proposed Cement brand is not approved by Ministry**
 - **Ministry Approved Brand**
 - **Maldives Cement**
 - **Villa Cement**
 - **RAK (OPC 42.5m).**
- Supply and delivery of accurate quantity of raw materials with industry standard quality. The cement supplied must comply with the BS 12 standard.
- All raw materials must be delivered in jumbo bags and on time. Raw materials will have to be delivered in two consignments as seen in Table 1.
- The supplier must deliver the raw materials to the RDC site in GDh. Gahdhoo.
- The supplier will be responsible for the loading and unloading of jumbo bags from delivery vehicles.

The quantity of raw materials required for the project are listed in Table 2 and the location of the RDC site in GDh. Gahdhoo is marked on GDh. Gahdhoo map in Figure 1.
