**Terms of Reference for
SUPPLY AND DELIVERY OF RAW MATERIALS FOR LH. HINNAVARU MAJOR ROADS
PROJECT**

1. BACKGROUND

Road Development Corporation Limited, an incorporated limited liability company operating under the registration number C10482019 and having its registered office at MSL Buildings, First Floor, Malé, Republic of Maldives (herein after called and referred to as “the Employer”), invites sealed tender from eligible bidders for supply and delivery of raw materials for Lh. Hinnavaru Major Roads project (hereinafter called the “Works” or “Project”).

2. SCOPE OF WORK

The Employer will finance the supply and delivery of raw materials for Lh. Hinnavaru Major Roads project. The scope of Works shall be as follows.

- Provision of the following documents with all consignments
 - The manufacturer’s details and specifications of the material
 - Manufacturer’s test certificate for all consignments
 - Third party test reports
- **Above documents must be submitted if the proposed Cement brand is not approved by Ministry**
 - **Ministry Approved Brand**
 - **Maldives Cement**
 - **Villa Cement**
 - **RAK (OPC 42.5m).**
- Supply and delivery of accurate quantity of raw materials with industry standard quality. The cement supplied must comply with either of the following standards: BS, EN, ASTM, ISO or IS.
- The raw materials must be delivered in jumbo bags and on time.
- The supplier must deliver the raw materials to the RDC site in Lh. Hinnavaru. The location of the RDC site at Lh. Hinnavaru is marked on Lh. Hinnavaru map (see Figure 1).
- The supplier will be responsible for the loading and unloading of jumbo bags from delivery vehicles.

The quantity of raw materials required for the project are listed below.

Raw Materials List	Quantity	Unit
Cement	2000	50 kg bags
Medium sand	4000	50 kg bags
