**Terms of Reference for
SUPPLY AND DELIVERY OF RAW MATERIALS FOR SH. MILANDHOO MAJOR ROADS
PROJECT**

1. BACKGROUND

Road Development Corporation Limited, an incorporated limited liability company operating under the registration number C10482019 and having its registered office at MSL Buildings, First Floor, Malé, Republic of Maldives (herein after called and referred to as “the Employer”), invites sealed tender from Local eligible bidders for supply and delivery of raw materials for Sh. Milandhoo Major Roads project (hereinafter called the “Works” or “Project”).

2. SCOPE OF WORK

The Employer will finance the supply and delivery of raw materials for Sh. Milandhoo Major Roads project. The scope of Works shall be as follows.

- The supplier must provide the following documents with all consignments.
 - The manufacturer’s details and specifications of the material.
 - Manufacturer’s test certification for all consignments.
 - Third party test reports
 - Product approval certificate from Ministry of National Planning, Housing and Infrastructure (MNPHI)
- Supply and delivery of accurate quantity of raw materials with industry standard quality. The cement supplied must comply with either of the following standards: BS, EN, ASTM, ISO or IS.
- All raw materials must be delivered in jumbo bags and on time to Sh. Milandhoo. Raw materials will have to be delivered in three consignments as seen in Table 2.
- ***Below are Cement brands approved by Ministry for reference:***
 - **Maldives Cement**
 - **Villa Cement**
 - **RAK (OPC 42.5m).**

The quantity of raw materials required for the project are listed in Table 1.
