### Implementation of Backup Software Solution

#### Introduction

Election commission of Maldives (herein referred as ECM) invites vendors to submit proposal for “Implementation of Backup Software Solution”. ECM requires consulting services to complete all components of this project including software installation, implementation, configuration, testing, etc.

#### Purpose

1. The purpose behind issuing this RFP is to provide information for technical and commercial bids from the eligible bidders for the above purpose.

#### Requirement

1. Enterprise Backup Software

#### Scope of Work

1. Supply of Enterprise Backup Software.
2. Install & Configuration of Enterprise Backup Software
3. Proper Software Training for ICT Team.
4. Prior to configuration and integration, the bidder needs to study the existing setup at ECM and prepare detailed implementation plan. This should not interrupt the current operations of ECM.
  - a. Hardware which will be provided
    - i. Dell PowerEdge R720 – Intel Xeon CPU E5-2620, 32GB RAM
    - ii. Dell PowerVault Tape Library 2000 with LTO5 Drive

#### Delivery and Installation Schedules

1. The Bidder shall deliver, install and configuration the software and integrate with existing environment within 21 Days from the date of delivery of the products at respective locations.
2. After completion of installation, the bidder should obtain sign-off on the Installation-cum-Acceptance certificate from the ECM official. ECM will carry out acceptance of hardware as per acceptance test plan.

Installation will be treated as incomplete in one/all of the following situations:

- Non-delivery of any software or other components, accessories, documentation, drivers media mentioned in the order.
- Non-delivery of supporting documentation.
- Delivery, but no installation of the components and/or software.
- System operational, but unsatisfactory to ECM.
