

REQUEST FOR PROPOSALS

Background

Eligibility:

- Bidders must be a registered business, corporation, firm, limited liability partnership, or government institution.
- Hikvision reseller certificate must be provided For Access Control Systems and Intruder Alarm Systems. Specified Model and Brand must be provided.

Requirement:

The firm should be a company/agency that provides technical support. The firm should have capacity and experience in installing Hikvision Access Control Systems.

- Vendor should send an expert in field related to Access control works (includes Door cutting and power connections)
- Party should have a minimum 1 year experience in this field.
- Any necessary works (such as Welding, modification of lock, etc) which may need to be done on site, should be included in the Installation price
- All Door Connections should be done including the Secure Unit.
- Vendor should provide an uplink cable in every access control system installing locations.
- 01 year warranty and free one year after sale services in Access Control Systems.
- Alarm Input of the Lock should be connected to the Hikcentral Software (should be able to use alarm input of the lock)
- The vendor must install the electric socket for the Access Control Systems (Price to be included within installation charges).
- All works related to Installation should be covered.
- Work with BML Security Staffs.
- Deliver the products on their offered duration
- Make sure no products are damaged before handing over.
- Cat 6 Cables should be used in every location
