

a. The partitions and doors shall be as per the below measurements.



b. Materials and Specifications:

- Partition frame shall be made with pine wood (or any equivalent)
- Partition shall be made with 6mm Gypsum board on both sides.
- Partitions shall be painted in high quality Semi-Gloss white paint.
- Doors shall be in aluminum and in white color.
- Each door shall be fixed with door handles and door locks.
- Number of partitions: 03
