MPL would like to engage a professional consultant to provide consultancy services for conducting an Enterprise Risk Assessment based on ISO 31000:2018, Internal Controls and Fraud Risk Management should comply with COSO Enterprise Risk Management (ERM) requirements as per requirement by Auditor General's Regulation on the Audit and Accountability of State-Owned Enterprises.

Objectives

The following are the goals (objectives) of this exercise:

- Streamline existing risk management processes with MPL's Risk Management Framework, ISO 31000:2018 standards' and COSO Enterprise Risk Management requirements.
- To ensure the strategies, practices, and skills necessary to apply ERM are institutionalized and embedded within the management structures of the MPL and its departments.
- To strengthen the organizational capability of ERM within MPL.
- To ensure that ERM is integrated within the strategies and performance processes of the MPL.

Scope of Works

- Conducting an enterprise-wide risk assessment which will result in an enterprise-wide risk register.
- Providing worksheets, templates and documents which will assist in the risk management process.
- Train MPL's Risk Unit on conducting risk assessments.
- Train "Risk Champions" from each department.

 - o Enterprise-wide risk register and risk register for individual departments with all the risks, controls, risk ratings, risk mitigating solutions, timeframe for addressing risks and the responsible persons.
- **Deliverable 02**
 - Templates, worksheets, documents, and processes to conduct the risk assessments.

Deliverable 03

- Risk report to the management outlining the risk assessment process, the key risks & the high-level risks facing the organization and recommendations for improvement of the Enterprise Risk Management system.
- Risk report must be presented to the management at the end of the risk assessment process.
- **Deliverable 04**
 - Basic training to the risk unit on conducting risk assessments. (04 participants)
- **Deliverable 05**
 - o Basic training to selected employees from each department on identifying, assessing, and evaluating risks. (20 participants)
 - Assisting Senior Executives in documenting the Risk Appetite statements and 0 aligning the Risk Registers with the attendant Risk Appetite.
 - Optional: Train the Trainer Course (04 participants)

Deliverable 06

- Supporting the development and application of the ERM strategy to the planning process and internal control systems. This should include methodologies with accompanying templates for:
 - **Risk registers**
 - Risk evaluation and prioritization ٠
 - Assessment of risk tolerance on the MPL (risk appetite)
 - Development of appropriate responses ٠
