Background

A major initiative for strengthening and assuring the quality of the education system is been conducted by the Quality Assurance Department (QAD). The main role of QAD is to monitor the quality of education and ensure that a higher standard of education system is developed and maintained across the Maldives.

Quality Assurance Department is required to evaluate and monitor schools in Maldives to ensure that they are equipped with competent staff, sufficient resources and have financial stability with a conductive learning environment. QAD is conducting School Reviews across the country with a target of completing all the schools in a three year cycle. A school review refers to a planned systematic monitoring procedure to determine the present status and condition of the schools. The findings of School Reviews have been shared with the stakeholders, emphasizing the areas for improvement and immediate attention. As this is the only whole-school monitoring activity currently carried out formally, the findings are imperative for establishing a quality education system in Maldives. However, currently there is no systematic mechanism by which the general findings can be shared with all the stakeholders. Further, the need to develop an annual report on the key finding from all the reviews undertaken every year has also been identified and so far a total of 110 reports need to be analyzed. For this task QAD is in need of technical support to do the analysis of the findings in these reports and develop and analytical report.

The overall objectives of this proposal:

a) To develop an analytical report on the key findings of the School Reviews (conducted by QAD) to analyse and document the key issues of quality, the key challenges faced by schools and stipulate policy level recommendations to address systemic issues.

Work Assignment

A local consultant will be hired to develop the analytical report. The Terms of Reference for the consultant are as follows.

- 1) Review the school review reports from 2016 and up to August 2017.
- 2) Identify the key issues and common challenges across all/most schools and provide an analysis on the issues and challenges.
- 3) Propose policy level recommendations to address the systemic issues
- 4) Validate the report with QAD.
- 5) Present the findings to the Senior Management Team (SMT) of Ministry of Education
- 6) Finalize the report with comments of the SMT.

The work shall be completed by 20th October 2017.
