  - (c) does not accept the correction of the Bid Price pursuant to Clause 25,

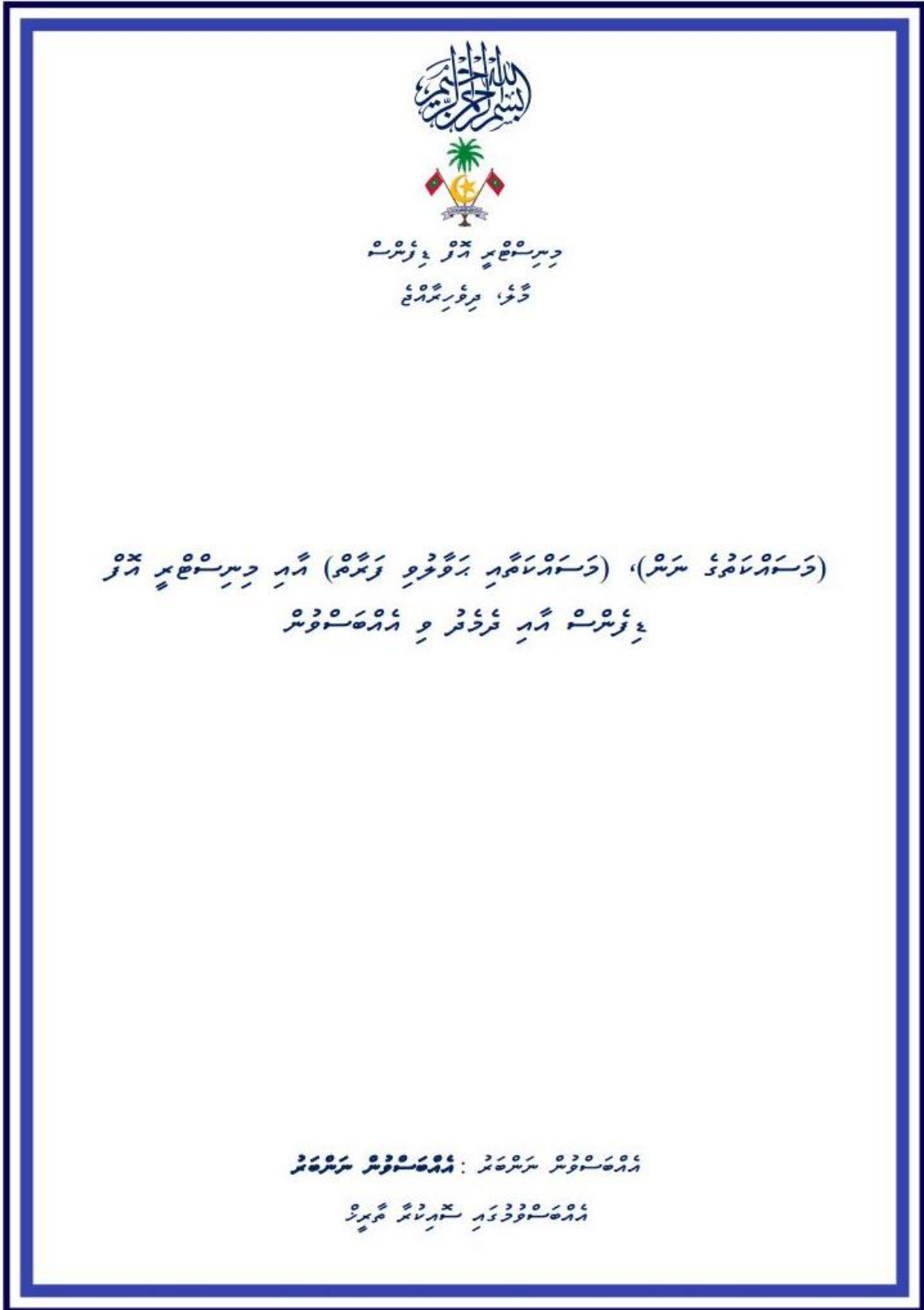
