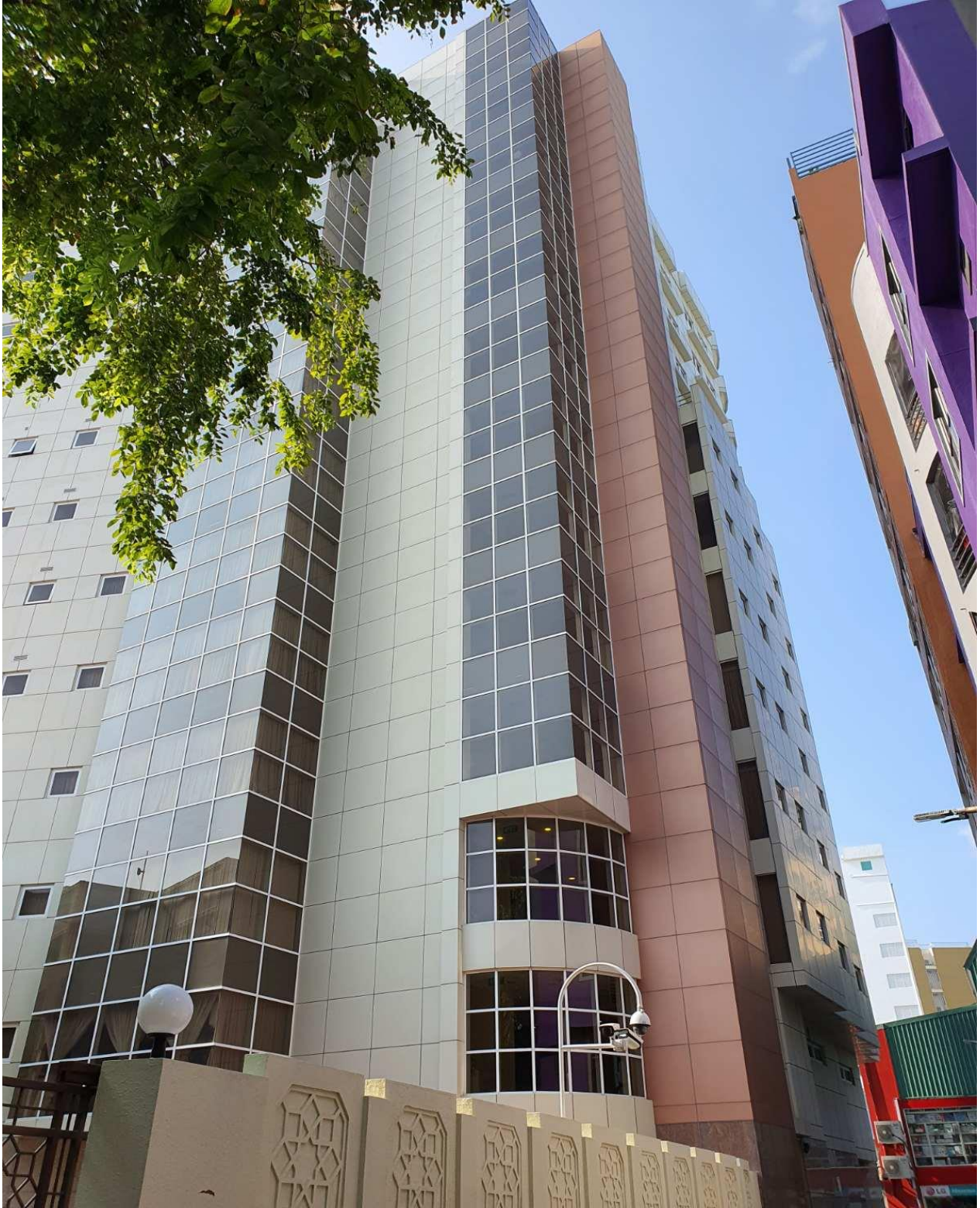


**2ND FLOOR PLAN TO TERRACE**

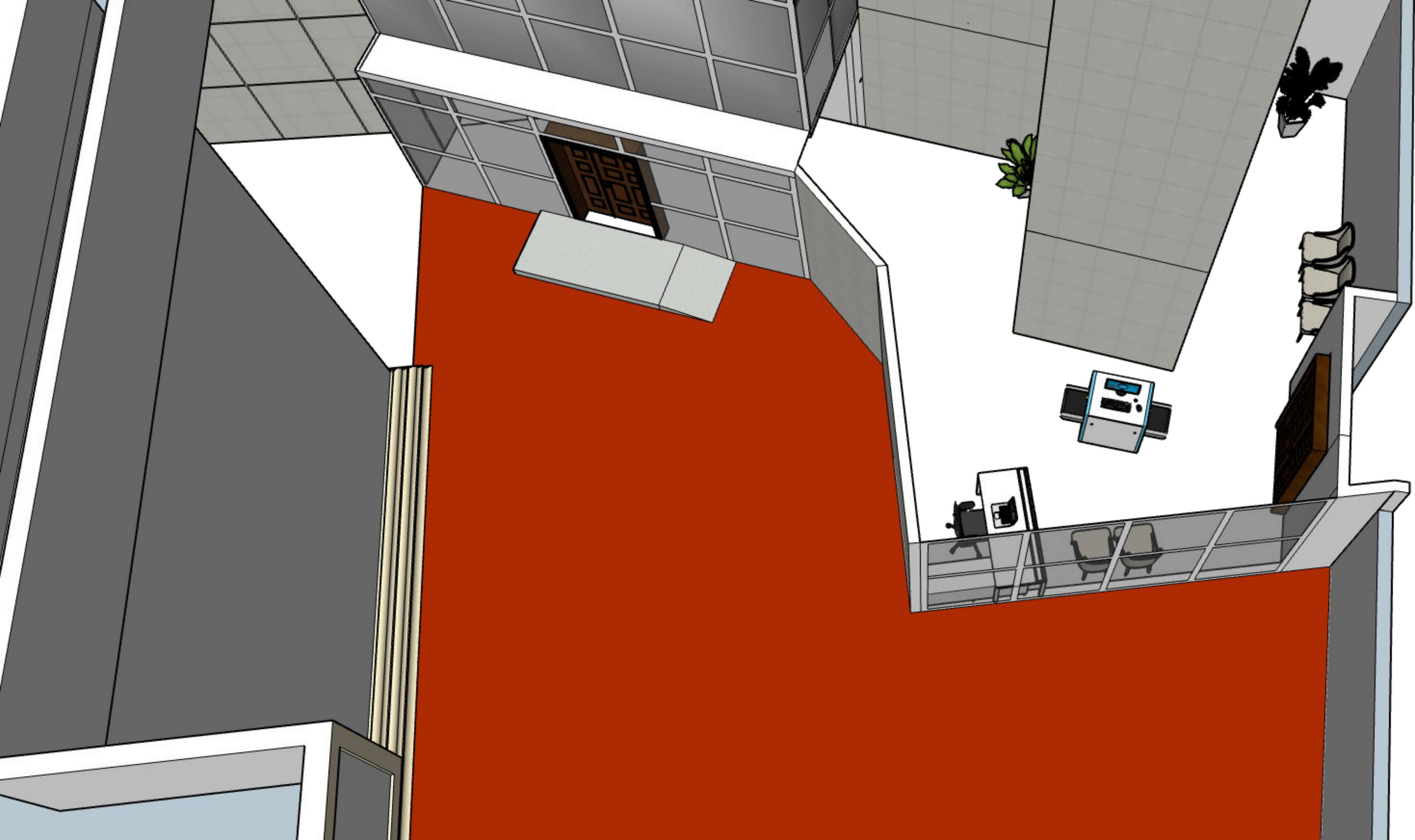
**VIEW BEFORE HAVING PROPOSED LIFT**

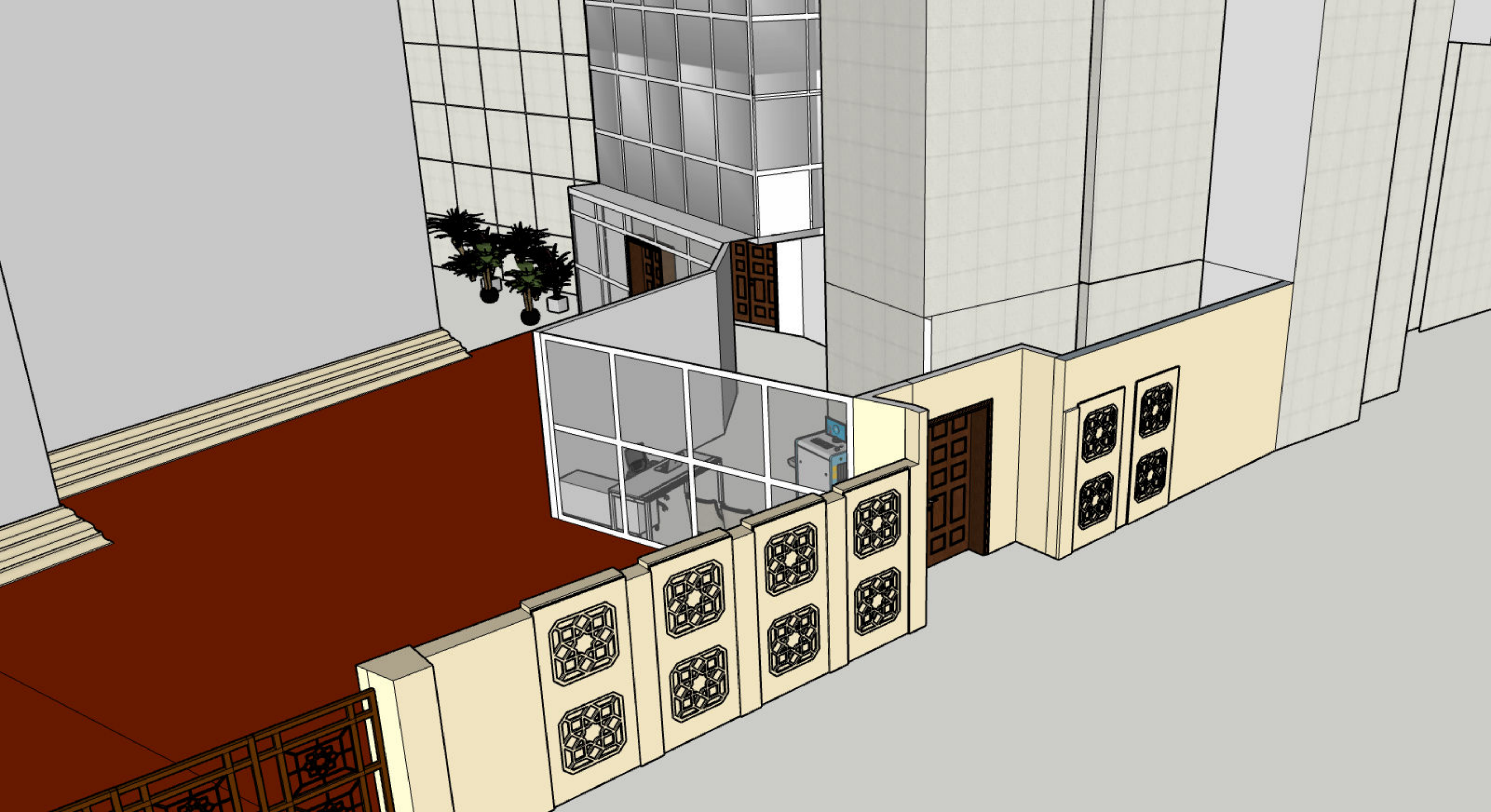


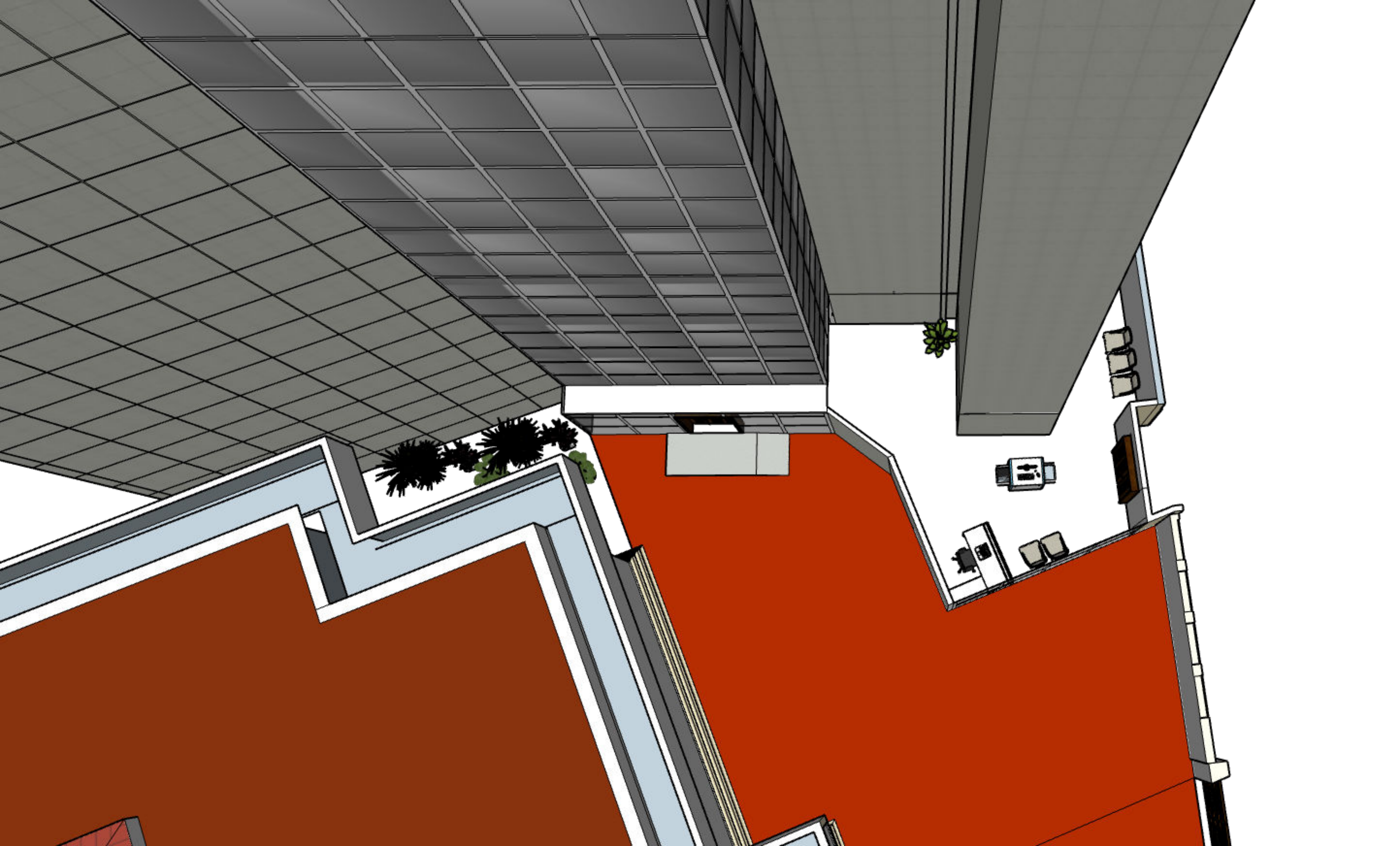

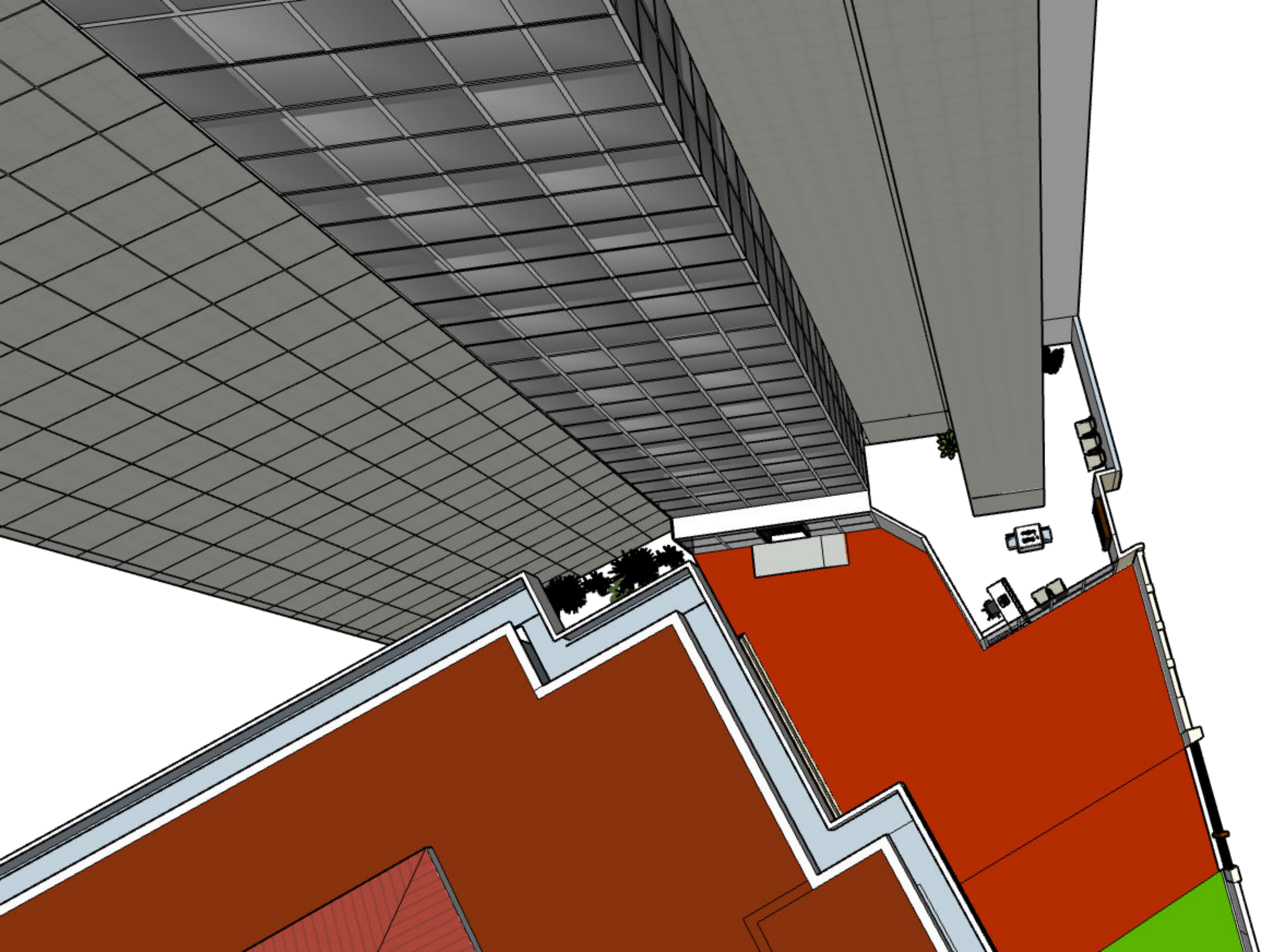
