Example: Find the area of the region bounded by the curve $y = \sqrt{x}$ and the x-axis from $x = 0$ to $x = 1$.
 (Solution) The area of the region is given by

$$A = \int_0^1 \sqrt{x} dx = \int_0^1 x^{1/2} dx = \left[\frac{2}{3} x^{3/2} \right]_0^1 = \frac{2}{3} (1)^{3/2} - \frac{2}{3} (0)^{3/2} = \frac{2}{3}$$
 Hence, the area of the region is $\frac{2}{3}$ square units.
