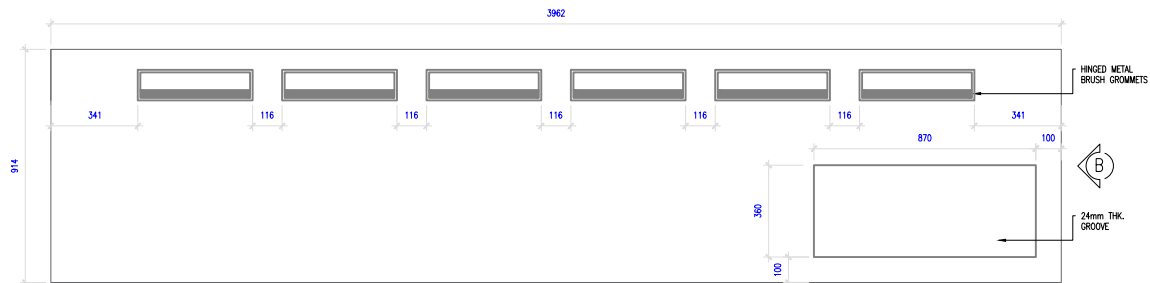

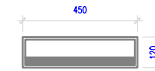

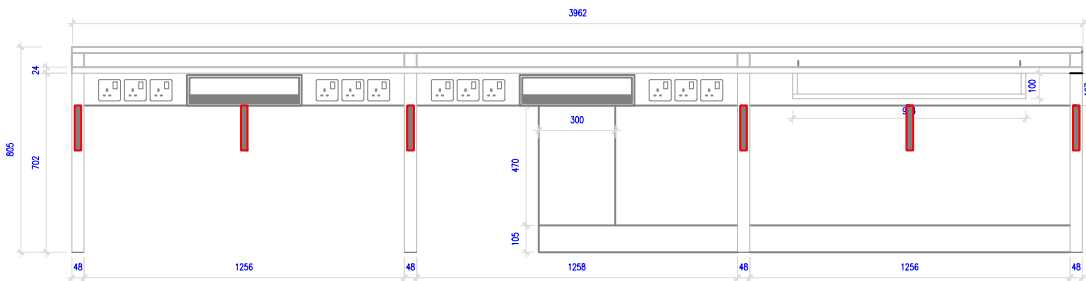


WORK DESK TOP VIEW

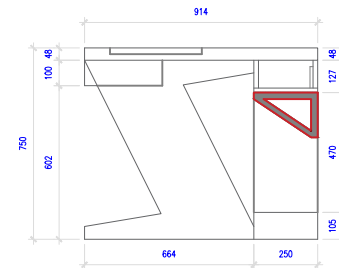


HINGED METAL BRUSH GROMMETS

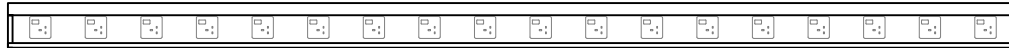

- 1) Every Pack of 3 Sockets shall be connected In parallel and Connected To Distribution Box Using
2.5mm² Standard Cable
- 2) All Sockets Must Be Single gang Universal Sockets.
- 3) Materials to be used
 - a) Balau wood or Pine wood
 - b) Hinged Metal Brush Grommets
- 4) L brackets shall be made from SS box pipe Brackets shall be mounted to the wall using anchor bolt.
- 5) Surface finishing shall be done before varnishing by grinding/filing/emery paper process.
- 6) Wood used in the furniture shall be seasoned wood with major defects, like dead knots with
through hole, wide cracks etc. Clear Poly Urethane lacquer polish shall be done on all wooden items.
