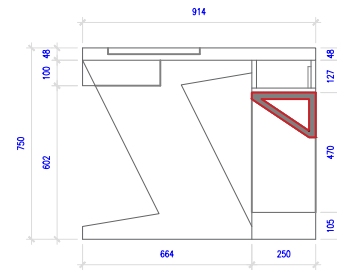

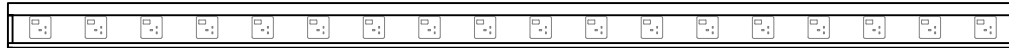
WORK DESK TOP VIEW
