SALE OF RECYCLABLE/SCRAP/REUSABLE MATERIALS

1. Background

Waste Management Corporation Limited (WAMCO) is a State-Owned Entity which is mandated to cater to the waste management needs of the nation in a sustainable and cost-effective manner. Formed in the year 2009, WAMCO's core business consists of waste collection, transfer, treatment & disposal. We rely on environmentally sustainable methods of waste management to minimize its impact on the ecosystem of the Maldives, with the objective to reduce, reuse and recycle of waste (3R concept). Our service portfolio caters to households, businesses, government entities, resorts and industrial islands across the nation. We commenced services to greater Male' region towards the end of 2016, and currently operate in 8 islands across the nation; approximately 43,430 customers comprising of both households and commercial entities.

Some level of segregation is carried out at all facilities, however due to the lack of resources i.e. space and equipment the corporation is unable to scale up the operations. At present there is around 200 to 300 tons of recyclable materials segregated and in loose form between all facilities of WAMCO. This includes plastic, metal, rubber, used oil and glass.

2. Scope of contract

- 2.1. Sale of recyclable materials from all regions where WAMCO offices are stationed. This includes short term project areas as well as long term/ permanent establishments.
- 2.2. Segregated recyclable materials available for sale includes but is not limited to Plastic (HDPE, PET, PP), metal (ferrous, non-ferrous), Glass, Paper (Cardboard, books, shredded mixed paper), battery and used oil.
- 2.3. Once the notice for collection (upon accumulation of a pre agreed tonnage/volume) is issued to the contractor collect and transfer the agreed volume/tonnage of recyclables is accumulated.









- 2.4. Main collection hubs are
 - 2.4.1. Seenu Hithadhoo
 - 2.4.2. Gnaviyani Fuvahmulah
 - 2.4.3. Kaafu Thilafushi and
 - 2.4.4. Raa Vandhoo.
- 2.5. Provide/assist with the setup of processing stations in the main collection hubs.
 Processing station includes vertical or horizontal compactors, balers, shredders etc.

3. Proposal

The proposal must include the following components

- 3.1. Company profile
- 3.2. Resources (Human, equipment, vessel, vehicles)
- 3.3. Proposed duration for clearance after materials are presented for purchase / or monthly schedule for collection (specify locations)
- 3.4. Proposed Collection Process or methods.
- 3.5. Documents showing experience in field (i.e. ongoing/completed projects, completion certificate, reference letter)
- 3.6. Declaration of pending or threatened litigations either against or by the buyer
- 3.7. Financial capability letter: last 3 (three) months Bank statement and the last 2 (two) years financial statements should be submitted to demonstrate the current soundness of the Financial Position.

4. Price proposal

The proposer shall complete the price proposal form attached as "Annex 1." The proposer must mention a price validity period, minimum validity period for the prices must be at least 4 months.

The buyer must submit an advance deposit of MVR 100,000.00 on a quarterly basis. Invoice amount will be deducted from the advance deposit and the remaining shall be paid within the allotted period mentioned on the invoice.







5. Delivery of Proposals

Proposals must be submitted to WAMCO, 11:00 a.m. (local time) on 24th May, 2022. Proposers must deliver one (1) original hard copy all pages must be signed and must bear the company seal (where applicable).

6. Proposal Preparation Costs

Issuance of this Request for proposal does not commit WAMCO, in any way, to pay any costs incurred in the preparation and submission of a proposal. WAMCO will not reimburse responding firms, including the selected firm, for any expenses incurred in preparing or submitting proposals. All costs related to the preparation and submission of a proposal shall be paid by the respondent.

8. Evaluation of Proposals

Proposals will be evaluated based on the following criteria:

1. Price / Proposal Cost: 70 points for the highest price

2. Reference / Experience letter: 30 points

A valid reference letter on completion of similar project/works should be provided. In case if a reference letter is not available, Sales Order with a Delivery Note, Agreement with Delivery Note or Invoice with delivery note will be accepted. 2 points will be given to each valid experience letter with supporting documents reaching maximum of 30 points.

Giving attention and submitting the below mentioned documents will be considered as an added advantage on evaluation.

- a) Experience in the Field/Work (completion letters)
- b) Proposed execution methodology (Beneficial for both)
- c) proposed approach, level of staffing and experience, vehicles, vessels and equipment/materials available
- d) Proposed duration for clearance after materials are presented for purchase / or monthly schedule for collection (specify locations)
- e) The buyer shall not appear on any globally recognized blacklists
- f) The buyer and its directors should not have been convicted of any criminal offence related to professional conduct
- g) The buyer shall not have court cases regarding dues to WAMCO
