Terms of Reference

Training of health workers in three regions of Maldives under SDF Project “Strengthening health system to effectively respond to Covid-19 situation; through early detection and, appropriate care and support for vulnerable and disadvantaged populations” - increasing and training of clinical workers in COVID-19 case management and other related health issues.

Objectives

- 1) Provide training for health workers on communicable diseases (Covid19, Dengue, HIV, Viral Hepatitis & other STI's)
- 2) Provide training for health workers on Global Competency Standards for health workers on Refugee and Migrant health, developed by WHO

Deliverables:

The expected tasks of this consultancy are as follows:

1. Contextualized training package developed, including handouts, presentations and other training tools.
2. Training for health workers conducted (total 3 trainings, in 3 regions)
3. Final report on the consultancy, including individual training reports.

Training should be designed to assist in developing the capacity of health workers in the Maldives to effectively respond to and manage the mentioned communicable diseases among the disadvantaged populations.

Trainings will be conducted in English and Dhivehi. Consultant should be proficient and familiar with the terminologies in English and Dhivehi.

Required Qualifications and Experience

The candidate/s should have the following skills and qualifications:

1. MBBS holder/ Bachelor's degree in Public Health/
2. Good communication skills and ability to coordinate activities with several different parties.
3. Expertise and proven high-quality work experience in conducting trainings on the topics identified
4. Preference will be given to locals and persons living in Maldives.

5. Consultant must be reachable by HPA anytime during working hours for the duration of assignment.

Duration

- An electronic copy of the training materials/ presentation should be submitted to HPA within 15 days of awarding the contract to the consultant
- All trainings will be conducted between August 2022 – November 2022.
