Design Build Outdoor frame and LED display at BML Head Office Rooftop

It is required to fix a frame and LED display on top of the BML Head Office building. And do all necessary arrangement required to bring LED display to working condition with commissioning for all LED programing required.

Contractor has to provide design for the frame, for the materials provided by BML

Scope of the Work

- Removing of existing BML letters with frame on the rooftop of Head Office Building and dispose it.
- Erection of LED stand and fixing it on the rooftop of BML Head Office building, and the LED stand should be easily accessible for maintenance with commission of LED for working condition. As the work is for outdoor display LED, water proofing should be included in the cost and covered under warranty period.
- LED size: 14.5m (Length) X 3m (Height) it should be fixed on the rooftop of the BML Head Office building.
- The RED color marked area only is required to fix LED

Required equipment should be borne by the contractor. Bank will provide major steels frame items and LED penal and related accessories. Contractor has to make contingency for additional items required to fix and operate LED display. Contractor has to transport the materials from Male and Hulhumale warehouses. at least 5 years warranty should be provided for the frame structure works.

• Will conduct site visit for the material locations to see the frame materials and LED items.
