- Base content on tourism context and adhere to Ministry's style guidance.
- Collaborate with Ministry teams to yield articles and ensure timely delivery.

2. Translate Tourism Law, related Regulations, and documents.

- Read through original material and translate it, ensuring that the meaning of the source text is retained.
- Commit to the quality of the content while being impartial and promoting integrity.
- Research legal, technical, and scientific phraseology to find the correct translation.
- Proofread and edited final translated documents.
- Provide a grammatically correct final version which should assist in the understanding of translated documents.
- Maintain a database of documents translated.
