# TERMS OF REFERENCE CONTENT CREATION FOR STRATA & TENANCY PORTAL

#### 1. INTRODUCTION

The Government has introduced initiatives to support and regulate new economic agenda throughout the islands of Maldives with the intention of promoting more efficient public expenditure on economic and social services. With these new initiatives, the Government of Maldives aims to provide extensive support in strengthening the level of intervention in the housing sector.

In support of the president's pledges under the Strategic Action Plan, the Ministry of National Planning, Housing, and Infrastructure (MNPHI) is developing online portal for strata management system & Tenancy portal under the "Strata Titles Act" and "Tenancy Act." Therefore, the Ministry is working to enhance a harmonized approach for management of housing and create public awareness of strata and tenancy managements.

Thus, the public and councils will utilize the two-primary housing-related portals that the government is creating. We seek a qualified party to develop content mentioned below along with our team. It is aimed to provide sufficient information to citizens, improve availability of data, strengthen coordination, and prevent duplication in delivery of support to individuals and companies in real estate developments.

#### 2. SCOPE OF WORK

- 1. Design and creation of graphic content for the portals website design related layouts, portal icons, Reports layout designing etc.
- 2. Design and creation of educational / awareness materials social media posts, material for tv programs, Banners, Posters, Booklets, leaflets, videos, flyers, info graphics etc.

#### 1. TIMEFRAME

The bidder should propose a detailed period for completing the project including milestones of this project starting from the commencement of the project.

#### 2. <u>FEE PROPOSAL AND PAYMENTS</u>

The bidder is expected to include the lump sum fee to carry out the tasks specified on the TOR on their proposal. The price proposed must be stated in both writing and in figures, and any proposal which has unclear statements may be rejected. The payments are made upon satisfactory completion and acceptance by MNPHI for the deliverables.

The bidder will work under the overall guidance and direct supervision of the MNPHI Team. As the project will be time constrained, the bidder shall provide an update on the progress during the project.
