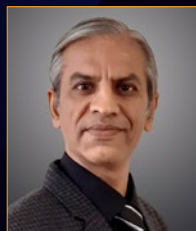

Middle East Variable Refrigerants Flow Conference (8th Edition)

Chilled water systems are at the core of exciting mega developments in the region, and DC Dialogue is a gathering of stakeholders at the forefront of the developments, including government regulators, District Cooling utility providers, sectoral end-users (healthcare, hospitality, education, aviation, malls, etc.), MEP consultants, MEP contractors, manufacturers and suppliers. Based on a unique format, the conference has a central narrator, who invites different players at various points in time to elaborate on what they worked on/or are working on, who in turn would invite the manufacturers collaborating with them.

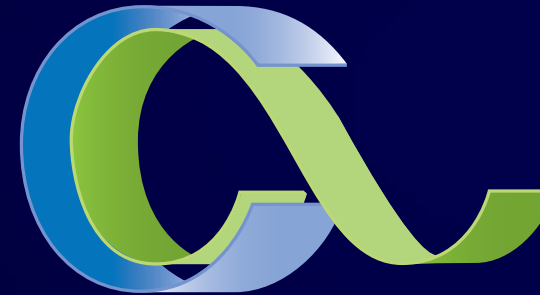
