Ingredients: coconut chips; soluble corn fiber; isomalto-oligosaccharide; inulin; purified water; sugarless chocolate glaze (sweetening agent: maltitol; cocoa butter; cocoa powder; emulsifier: soy lecithin; flavoring agent), water-retaining agents: sorbitol syrup; glycerin; acidity regulator: ascorbic acid, citric acid; flavoring agent; antioxidant: a mixture of tocopherols; preservation agent: sorbic acid.

Ingredients: whey protein concentrate; milk protein concentrate; isomaltooligosaccharide, coconut oil; purified water; sugarless chocolate glaze (sweetening agent: maltitol; cocoa butter; cocoa powder; emulsifier: soy lecithin; flavoring agent); water-retaining agents: sorbitol syrup, glycerin; peanut; peanut butter; emulsifier: soy lecithin; acidity regulator: citric acid, ascorbic acid; insoluble wheat fiber; flavoring agent, preservation agent: sorbic acid.

1. MOQ - 5000\$
2. Minimal order per flavor 1500 pcs - bars\ 4500 - candies
3. Shelf time - 12 months
4. Estimated delivery time - 60 days from label registration
5. Label registration - up to 60 days

Product ordering stages

1. Product type selection
2. Selecting product size (bar/candy, weight variations)
3. Choice of ready-made flavors
4. Coordination of the place of receipt of the order (country, city, address)
5. Signing of the contract
6. Make an advance payment of 20% to start work on the project
7. Providing the customer with a product design(label and box) or technical specifications for its development (we will provide 2 concepts to choose from with the opportunity to make up to 3 edits).
8. Obtaining production permission from government agencies
9. Working with the printing house. Selecting materials for labels and boxes. Selecting box size.*
10. After receiving permission for production, transfer of labels and boxes to the printing house for printing.
11. Signing a color proof for packaging

Product ordering stages

12. Receipt of packaging and confirmation of print quality at the manufacturer's warehouse
13. Payment of 50% by the customer
14. Placing an order in the manufacturer's production plan
15. Preparation of a free trade certificate (if necessary)
16. Production of goods
17. Notification of order readiness by email with photo and video.
18. Payment of the remaining 30% of the order value.**
19. Delivery of the order to the place of receipt according to the contract

**The actual quantity produced may vary up to 10% up or down

*The minimum order quantity for a label is 10 kg; if within a year the customer does not use the entire volume of the label purchased by the manufacturer, the customer is obliged to buy the rest of it, according to the prices at which the manufacturer purchased the packaging from the printing house.
