Grain Processing Division

- The Plant for the production of rice groats, Krasnodar Territory
 2 500 tons of rice groats per month. It is a modern enterprise equipped with highly productive South Korean adapted equipment.
- The Plant for the production of buckwheat groats, Altai
 Territory 2 400 tons of buckwheat groats per month. It manufactures premium grade and first-grade whole-grain quick-cooking buckwheat groats.
- The Plant for the production of breadcrumbs, Kaluga Region -900 tons of breadcrumbs per month. It produces breadcrumbs of various colors and traditional Japanese Panko breadcrumbs.
- The Pasta factory, Voronezh Region 1 000 tons per month, producing long and short-cut pasta of groups A and B.
- «Kardail FlourMilling Plant», Voronezh Region 8 000 tons of wheat flour and 4 000 tons of rye flour per month. A significant portion of the "Kardail FlourMilling Plant" production is exported to Afghanistan, Iraq, Syria, Tajikistan, Pakistan, Georgia, and Abkhazia.

- We are installing additional production lines at the pasta factory and building a milling complex to provide the factory with its own raw materials.
- We are expanding into the FMCG market segment in the grocery sector.










Sales Territory Map
