Grains & Oilseeds

Originating, storing, transforming and merchandizing a wide range of grains, oilseeds and their by-products:

soy (beans, meals and oils), camelina, canola, rapeseed, cottonseed, sunflower seeds, peanuts, palm meals and oils (crude and refined, bulk and bottled), wheat, white and yellow corn, dried distillers' grains, sorghum, barley, rye, oats, chickpeas, biodiesel, ethanol, fertilizers, inputs and seeds.

Juice

Originating, processing and merchandizing orange, lime, lemon and apple juices, natural citrus flavor and fragrance ingredients, dry peel (for pectin extraction) and citrus pulp pellets (for animal feed).

Rice

Merchandizing and securing supplies of the world's most significant staple food crop, including paddy, brown, milled and parboiled and premium rice (bulk and packaged).

Sugar

Supplying beet, cane raw, crystal and refined sugar, as well as ethanol, to key consumer markets.

Animal Feed

Aquatic feed, canola meal, citrus pulp pellets, cottonseed meal, distillers solubles, dried distillers grains with solubles (DDGS), feed barley, feed grain, glycerin, lecithin, molasses, palm kernel expellers (PKE), peanut meal, rapeseed meal, soybean hulls, soybean meal.

Food & Beverages

Cereals, coffee, edible oils (canola, coconut, corn, flaxseed, grape seed, linseed, olive, palm, perilla seed, peanut, rapeseed, rice bran, safflower, soy, and sunflower), fruit juices and citrus ingredients, pulses, rice, sugar.

Ingredients

Lecithin, glycerin, specialty feed protein.

Pharmaceuticals & Cosmetics

Citrus oils & aromas, coconut fatty acid distillate, crude coconut oil, crude peanut oil, glycerin, lecithin, palm soap noodle, palm soap bar, tocopherol.

Soy and pea protein isolates.

Biodiesel, ethanol, palm fatty acid distillate.

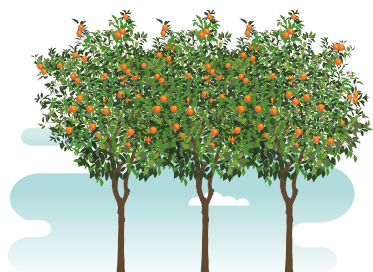
